A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF TRANSPORTATION'S ENGINEERING SCHOLARSHIP PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to establish a civil
- 2 engineering scholarship program to be administered by the
- 3 department of transportation and to appropriate moneys to
- 4 promote the civil engineering profession, and offer financial
- assistance, on-the-job training, and employment opportunities to 5
- 6 qualified students in Hawaii.
- 7 SECTION 2. Chapter 78, Hawaii Revised Statutes, is amended
- 8 by adding a new section to be appropriately designated and to
- 9 read as follows:
- 10 "\$78- Department of transportation; civil engineering
- 11 scholarship program. (a) The department of transportation may
- 12 establish a civil engineering scholarship program open to high
- 13 school graduates of accredited high schools in Hawaii, or high
- 14 school graduates who are residents of Hawaii, who have
- 15 successfully completed a high school pre-college curriculum.
- 16 The department of transportation shall establish, without regard
- 17 to chapter 91, the criteria and guidelines for the scholarship

- 1 program that shall include but not be limited to qualification
- 2 requirements, conditions for the scholarship, reimbursement
- 3 provisions, and alternate options in which a scholarship
- 4 participant may participate to otherwise fulfill the
- 5 participant's employment obligation under a scholarship
- 6 agreement, if the participant is not hired by the department of
- 7 transportation.
- **8** (b) The tuition component amount of a civil engineering
- 9 scholarship award shall be limited to the resident tuition cost
- 10 of the University of Hawaii at Manoa.
- 11 (c) Students awarded scholarships shall agree by contract,
- 12 with the written approval of a parent or legal guardian when the
- 13 applicant is under eighteen years of age, to apply for full-time
- 14 civil service employment with the department of transportation
- 15 immediately after graduation from an accredited civil
- 16 engineering program at the University of Hawaii and accept any
- 17 position offered and, if hired, complete one year of full-time
- 18 employment with the department of transportation for each school
- 19 year in which the participant participated in the scholarship
- 20 program. A participant who fails to:
- 21 (1) Graduate from an accredited civil engineering program
- 22 at the University of Hawaii;

- 1 SECTION 3. There is appropriated out of the highways
- 2 special fund, highways administration, the sum of \$100,000 or so
- 3 much thereof as may be necessary for fiscal year 2007-2008 to
- 4 implement the department of transportation's civil engineering
- 5 scholarship program.
- 6 The sum appropriated shall be expended by the department of
- 7 transportation for the purposes of this Act.
- 8 SECTION 4. New statutory material is underscored.
- 9 SECTION 5. This Act shall take effect upon its approval.
