A BILL FOR AN ACT

RELATING TO THE ISLAND OF KAHO'OLAWE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 340, Session Laws of Hawaii 1993, mandated
2	that the island of Kaho'olawe be reserved in perpetuity for uses
3	such as:
4	(1) The preservation and practice of rights customarily
5	and traditionally exercised by native Hawaiians for
6	cultural, spiritual, and subsistence purposes;
7	(2) The preservation and protection of the island's
8	archaeological, historical, and environmental
9	resources; and
10	(3) Education.
11	Accordingly, the Kaho'olawe island reserve commission plans
12	to establish culture and education centers, operations
13	facilities, overnight campsites, restoration areas, and cultural
14	and wildlife preserves on the island.
15	Because Kaho'olawe is geographically and logistically
16	isolated from the other Hawaiian islands, concerns have emerged
17	regarding appropriate power sources and adequate fuel supplies
18	to successfully maintain planned facilities and operations.

1 In keeping with the Kaho'olawe island reserve commission's mandate and vision to restore, preserve, and maintain a pristine 2 3 natural environment on the island, the use of alternative energy resources for the island's power needs should be considered. 4 5 The State is in the unique position of establishing Kaho'olawe as a model project for sustainability and alternative energy 6 7 research and application that can be used to plan for the future 8 power needs of not only Kaho'olawe, but the entire State as 9 well. In this regard, the State Planning Act, chapter 226, 10 Hawaii Revised Statutes, identifies increased energy self-11 sufficiency as one of the State's energy objectives. 12 The purpose of this Act is to direct the auditor to 13 determine the feasibility of deploying alternative energy 14 resources to meet the island's energy needs and submit a report 15 of findings and recommendations to the legislature and governor 16 prior to the convening of the regular session of 2008. 17 SECTION 2. The auditor shall conduct an audit to determine the feasibility of deploying alternative energy resources to the 18 19 island of Kaho'olawe. The audit shall identify feasible 20 alternative energy resources and shall include a cost analysis, 21 assessment, infrastructure and transportation needs analysis, 22 and an implementation strategy for the use of alternative energy

- 1 resources to address the current and future energy needs of the
- 2 island.
- SECTION 3. The auditor shall submit findings and 3
- 4 recommendations, including any proposed legislation, to the
- 5 legislature and the governor no later than twenty days prior to
- the convening of the regular session of 2008.
- SECTION 4. This Act shall take effect on July 1, 2007. 7
