A BILL FOR AN ACT

RELATING TO MOTOR SCOOTER AND MOPED HELMET USAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 63, Session Laws of Hawaii 2006, requires a 2 person under the age of eighteen to wear a safety helmet when 3 operating a moped or riding as a passenger on a moped. The 4 legislature finds that helmets should be required to be worn by 5 all persons while operating or riding as a passenger on a moped, or while operating or riding as a passenger on a motor scooter, 6 7 regardless of age. The same safety and policy issues pertain to 8 a motor scooter, which is only slightly more powerful, as to a 9 moped.

10 The purpose of this Act is to require all persons to wear a 11 helmet while operating or riding as a passenger on a moped, or 12 while operating or riding as a passenger on a motor scooter. 13 SECTION 2. Section 286-81, Hawaii Revised Statutes, is 14 amended by amending subsections (a) and (b) to read as follows: 15 "(a) No person shall:

16 (1) Operate a motorcycle or motor scooter, on any highway17 in the State unless the person and any passenger the

(C) Any other protective devices required by the 3 [(B)] 4 rules adopted by the director for the use of the 5 person or persons intending to operate or ride as 6 a passenger on the motorcycle or motor scooter; 7 provided that any person to whom a motorcycle or 8 motor scooter is leased or rented may furnish for 9 the person's own use the protective devices 10 required by this part.

11 For the purposes of meeting the requirements of this 12 paragraph, a required device shall meet the 13 specifications and requirements established by rules 14 adopted by the director; or

15 (3) Sell or offer for sale or furnish any safety helmet,
16 safety glasses, goggles, face shield, windscreen,
17 windshield, or other protective devices represented to
18 meet the requirements of this part unless the device
19 meets the specifications and requirements established
20 by rules adopted by the director.

(b) No person less than eighteen years of age shall
operate or ride as a passenger on a motorcycle [or motor

1 scooter] on any highway in the State unless the person wears a 2 safety helmet securely fastened with a chin strap." 3 SECTION 3. Section 291C-195, Hawaii Revised Statutes, is 4 amended by amending subsection (a) to read as follows: 5 "(a) No person less than fifteen years of age shall drive 6 a moped on a highway, street, roadway, or any other public 7 property in the state. No person [less than eighteen years of 8 age] shall drive a moped unless the person wears a safety helmet 9 securely fastened with a chin strap. The safety helmet shall 10 meet the specifications and requirements established by rules 11 adopted by the director." 12 SECTION 4. Statutory material to be repealed is bracketed 13 and stricken. New statutory material is underscored. 14 SECTION 5. This Act shall take effect upon its approval. INTRODUCED BY: Jufnh. 15
