# A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There are serious problems in Hawaii that 2 compromise the well-being of its people. For example, an 3 average of eleven infants under the age of one die each month 4 due to accidents, neglect, maltreatment, or other causes. At 5 the other end of the life continuum, between 2000 and 2030, the 6 number of individuals who are sixty years and older will 7 increase by ninety-four per cent, and the number of those 8 eighty-five years and older will grow by one hundred seventyfive per cent. Our state is not prepared for the significant 9 10 number of elders who will require supportive services. То 11 exacerbate the situation, Hawaii has too many individuals and 12 families who are struggling financially due to the wide gap 13 between their incomes and basic living expenses. There are also 14 a considerable number of people living unsheltered, and 15 approximately one-third of those receiving homeless services are 16 children.

1 The University of Hawaii center on the family's data, 2 information, and training raise the educational capital of the state and improve its capacity to meet the challenges of these 3 4 and other problems. The center monitors key indicators relating to children, families, and the elderly in Hawaii to assess their 5 well-being over time, identify problem areas, and track the 6 7 effect of policies and programs. It provides the most 8 comprehensive collection of data and information on children, 9 families, older adults, and communities through its web-based 10 data center. The data center has received a national award of 11 excellence and distinguishes Hawaii as the only state in the 12 nation with a website containing data and publications focused on the aging population locally. The center's educational 13 14 materials have been widely used in classrooms and the community 15 to raise awareness and increase knowledge in various areas, 16 including:

- 17 (1) Child development and care;
- 18 (2) The building of strong families;
- 19 (3) Drug use among youth;
- 20 (4) Demographics of older adults; and
- 21 (5) Hawaii's vulnerable people, such as the homeless and22 abused.

1 Some of the center's materials have been first reports on 2 important subjects, for which valid and reliable data had not 3 previously been available (e.g., the report on homeless 4 individuals and families receiving services in Hawaii, community 5 profiles on forty-three school complex areas, and the economic self-sufficiency report that was done in partnership with the 6 Aloha United Way). In addition, the center's training and 7 8 outreach improve the organizational capacity, leadership, and 9 staff competence of many community groups.

10 Because of its value to both governmental and community nonprofit agencies, it is important to sustain the efforts of 11 12 the center on the family and enable the center to continue to 13 contribute to the state's educational capital. Policymakers, 14 program directors, service providers, and advocates need and 15 benefit from the center's work. They use it to gain a better 16 understanding of significant issues confronting Hawaii, improve 17 decision-making, develop policies and proposals that secure 18 millions of dollars for the state, prepare reports and program 19 materials, and enhance services to the state's poorest 20 residents. These activities, in turn, improve the quality of 21 life for all the people of Hawaii.
