A BILL FOR AN ACT

RELATING TO ELECTRIC WHEELING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that Hawaii relies on 1 imported oil to meet over ninety per cent of the State's energy 2 needs, leaving the State vulnerable to supply interruptions and 3 oil price volatility. Bold action is needed to chart a 4 progressive energy strategy for the State that should include 5 the integration of Hawaii's indigenous energy resources in 6 electricity production to promote economic stability, enhance 7 energy security, and demonstrate environmental stewardship. 8 9 The purpose of this Act is to require the public utilities commission to establish a wheeling tariff to enable suppliers of 10 electricity to use the transmission and distribution facilities 11 of an electric utility to distribute power to the suppliers' 12 13 end-use customers.
