RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the unprecedented SECTION 1. 2 growth that west Hawaii has experienced over the last several 3 decades and continuing into the twenty-first century has exacted 4 an enormous toll on the physical infrastructure serving the 5 residents of west Hawaii. At the same time, it is demanding the increase of all types of government services to ensure the 6 7 public's health, safety, and welfare. Offices housing government agencies and quasi-public organizations providing for 8 9 the public's safety have proliferated all over west Hawaii.

10 The legislature believes that there is a vital need to plan 11 for the coordinated provision of public safety services and that 12 a multi-purpose complex in west Hawaii to concentrate public 13 safety agencies in one central area would be cost-efficient, 14 provide better communications among provider and users of public 15 safety services, and could improve access to such services.

16 It is the intent of the legislature that this multi-purpose
17 complex may house circuit and district courts and judiciary
18 offices, public safety offices, detention facilities, police

1 Hawaii region bounded by Palani road to the south, Mamalahoa highway to the east, Kawaihae road to the north, and the ocean. 2 3 Within ninety days of the effective date of this Act, the department of land and natural resources shall provide to the 4 5 department of accounting and general services a prioritized list 6 of parcels of public lands, together with plat and topographic 7 maps, within the area described in this section that may be 8 suitable to the development of a multi-purpose public safety 9 complex, comprising of a minimum of acres and taking into 10 consideration the county of Hawaii general plan, topography, 11 accessibility to essential infrastructure, and ease of public 12 access.

SECTION 3. (a) The department of accounting and general services shall establish a task force to plan the development of the multi-purpose public safety complex in west Hawaii, which shall include but is not limited to the following officials or their designated representative:

Federal agencies, including but not limited to the Federal Emergency 5 6 Management Agency, Department of the Interior, United States 7 Attorney's Office, United States Marshall Service, and United 8 States Courts should be consulted to determine whether they 9 would be interested in participating with the work of the task 10 force and be a future occupant of the west Hawaii public safety 11 complex.

12 (d) In developing the conceptual plan, the task force13 shall incorporate the following:

14 (1) Extensive public participation, including the concept
15 of the charette, a technique used by planning
16 practitioners to involve individuals and organizations
17 of a community directly in the planning, programming,
18 and design of a project;
19 (2) The inclusion of smart growth concepts, including but
