A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR UNIVERSITY OF HAWAII HEALTHCARE WORKFORCE SIMULATION RESOURCE LABORATORIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that healthcare
- 2 organizations take seriously their responsibility to deliver
- 3 safe and competent care to their patients and clients.
- 4 Professions that have an inherent level of risk, such as
- 5 healthcare disciplines, are using simulation as a means to train
- 6 individuals and teams to learn new techniques and handle
- 7 unanticipated and crisis situations without real world
- 8 consequences. The University of Hawaii nursing programs are a
- 9 resource to aid the State's response to patient safety and
- 10 nursing workforce demand. Simulation learning contributes to
- 11 both of these outcomes by providing additional clinical
- 12 experiences, expanding the teaching capacity for students, as
- 13 well as preparing nurses with hands-on learning without the
- 14 real-world consequences. According to the Joint Commission on
- 15 Accreditation of Healthcare Organizations September 2006
- 16 newsletter, simulation learning can ensure patient safety in two
- 17 ways:

1	(1)	Allowing clinicians to gain experience with a wide
2		range of specific scenarios, without necessitating
3		that they practice on patients; and
4	(2)	Helping staff to improve their skills and thereby
5		providing their real-life patients with safer, higher-
6		quality care.
7	Simulation training ranges from basic skills building, to	
8	the use of trained actors playing patients, to full-blown	
9	enactments of specific clinical scenarios such as a particularly	
10	difficult surgery, complete with electronic mannequins that are	
11	programmed to act and react like actual human patients.	
12	Dedicated simulation centers provide a wider range of simulated	
13	scenarios because the areas are designed to allow training to be	
14	recorded and reviewed more comprehensively and simulation	
15	equipment is already in place.	
16	The	legislature further finds that simulation is a valuable
17	tool when	used in conjunction with classroom and clinical
18	education	. Further, simulation learning can offer a series of
19	challenging simulated scenarios for effective continuing	
20	education offerings to healthcare professionals and provide	
21	experience to multidisciplinary groups, such as medical	
22	emergency teams or disaster-preparedness response teams.

- 1 Finally, simulation can be used to certify competency of the
- 2 existing workforce.
- 3 The legislature recognizes that the experience of the
- 4 University of Hawaii at Manoa school of nursing and dental
- 5 hygiene in operating a clinical simulation laboratory shows that
- 6 this approach is embraced by faculty, students, and employers
- 7 alike resulting in improved learning outcomes that enhance
- 8 patient safety. As such, the initial expenses associated with
- 9 simulation are outweighed by the benefits to patients.
- 10 The purpose of this Act is to appropriate funds to
- 11 establish a dedicated network of healthcare workforce simulation
- 12 resource laboratories on the islands of Oahu, Kauai, Maui, and
- 13 Hawaii for cross-disciplinary workforce education and training
- 14 to improve communication, outcomes, and patient safety to better
- 15 meet the needs of Hawaii's population. Once established, the
- 16 laboratories will serve as the community focal point for nurse,
- 17 physician, emergency response, and other healthcare worker
- 18 training and competency certification with operating costs and
- 19 staffing to be funded through contracts and fees.
- 20 SECTION 2. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$10,000,000, or so
- 22 much thereof as may be necessary for fiscal year 2007-2008, and



- 1 \$2,000,000, or so much thereof as may be necessary for fiscal
- 2 year 2008-2009, for the University of Hawaii to establish a
- 3 network of healthcare workforce simulation resource laboratories
- 4 at Kauai community college, Maui community college, and the
- 5 University of Hawaii at Hilo, jointly used and operated by the
- 6 University of Hawaii at Hilo and the Hawaii community college,
- 7 and to expand the simulation laboratory at the University of
- 8 Hawaii at Manoa, to be used in conjunction with Kapiolani
- 9 community college.
- 10 SECTION 3. The sums appropriated shall be expended by the
- 11 University of Hawaii for the purposes of this Act.

12 SECTION 4. This Act shall take of fect on July 1, 2007.
