A BILL FOR AN ACT

RELATING TO DENTISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 448-17, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) The board shall refuse to issue a license to any
4	applicant who fails to meet all of the requirements imposed by
5	this chapter and may refuse to issue a license to any applicant
6	who has previously committed any act [which] <u>that</u> would, if
7	committed by a licensee, result in the revocation or suspension
8	of the license.
9	In addition to any other actions authorized by law, the
10	board may suspend or revoke any license issued under this
11	chapter and may fine a licensee for any cause authorized by law,
12	including but not limited to the following:
13	(1) Fraud in procuring license;
14	(2) Habitual intoxication or addiction to the use of
15	drugs;
16	(3) Wilful or repeated violations of the rules of the

department of health;


