### A BILL FOR AN ACT

RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 323F-1, Hawaii Revised Statutes, is
2	amended by amending the definitions of "division", "health
3	facility" and "health system assets" to read as follows:
4	PART I. GENERAL PROVISIONS
5	[§323F-1] Definitions. As used in this chapter, unless
6	the context otherwise requires:
7	"Consumer" means any individual who may utilize a Hawaii
8	health systems facility for health services and is not a
9	provider.
10	"Corporation" means the body corporate and politic known as
11	the Hawaii health systems corporation.
12	"Corporation board" means the board of directors of the
13	corporation.
14	"Department" means the department of health.
15	"Director" means the director of health.
16	"Division" means the programs, services, and facilities
17	operated by the department of health, division of community
18	hospitals, prior to the transfer date, and Kahuku Hospital.

"Health facility" means any one of the facilities that
 constitute the division of community hospitals and Kahuku
 Hospital.

Health systems assets" means all property or rights in
property, real, personal and mixed, tangible or intangible,
existing on the transfer date, used by or accruing to the
division in the normal course of its operations and Kahuku
Hospital.

9 "Provider" means any supplier of medical or health care
10 goods and services of the type provided at a Hawaii health
11 systems facility.

12 "Transfer date" means a date agreed to by the department 13 and the corporation for the transfer of health systems assets to 14 and the assumption of health systems liabilities, which includes 15 without limitation, all debts or other obligations, contingent 16 or certain, owing on such date, by the corporation."

SECTION 2. New statutory material is underscored.
SECTION 3. This Act shall take effect upon approval, only

appropriation of moneys to Kahuku Hospital for payment of
