A BILL FOR AN ACT

RELATING TO ABORTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 453, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§453- Performance of partial birth abortion prohibited.
- 5 (a) Except as otherwise provided in subsection (b), a physician
- 6 or an individual performing an act, task, or function under the
- 7 delegatory authority of a physician shall not perform a partial
- 8 birth abortion, even if the abortion is otherwise permitted by
- 9 law.
- 10 (b) A physician or an individual described in subsection
- 11 (a) may perform a partial birth abortion if the physician or
- 12 other individual reasonably believes that performing the partial
- 13 birth abortion is necessary to save the life of a pregnant woman
- 14 whose life is endangered by a physical disorder, physical
- 15 illness, or physical injury and that no other medical procedure
- 16 will accomplish that purpose.
- 17 (c) This section does not create a right to abortion.



1	<u>(d)</u>	Notwithstanding any other part of this section, a		
2	person shall not perform an abortion that is prohibited by law.			
3	<u>(e)</u>	(e) As used in this section:		
4	"Abortion":			
5	(1)	Means the intentional use of an instrument, drug, or		
6		other substance or device to terminate a woman's		
7		pregnancy for a purpose other than to:		
8		(A) Increase the probability of a live birth;		
9		(B) Preserve the life or health of the child after		
10		live birth; or		
11		(C) Remove a dead fetus; and		
12	(2)	Does not include a procedure to complete a spontaneous		
13		abortion or the use or prescription of a drug or		
14		device intended as a contraceptive.		
15	<u>"Fet</u>	us" means an individual organism of the species homo		
16	sapiens at any time before complete delivery from a pregnant			
17	woman.			
18	"Partial birth abortion" means an abortion in which the			
19	physician or individual acting under the delegatory authority of			
20	the physician performing the abortion partially vaginally			
21	delivers a living fetus before killing the fetus and completing			
22	the delivery."
