[+] The director of transportation is 5 directed to establish and certify a statewide driver education program and behind-the-wheel driver training program, to include 6 7 the number of course hours, curriculum, and certification of 8 teachers and third-party examiners [-], and an optional accident 9 prevention program for purposes of section 431:10C-207. 10 director of transportation is also directed to set a cost for 11 the programs to enable the programs to be self-sufficient. 12 director of transportation shall adopt rules pursuant to chapter 13 91 necessary for the purposes of this [4] section[4]." 14 SECTION 2. Section 431:10C-207, Hawaii Revised Statutes. 15 is amended to read as follows: 16 "§431:10C-207 Discriminatory practices prohibited[-]; 17 accident prevention program; exception. 5	(b) Notwithstanding subsection (a), beginning January 1,

10	insurance polices in effect on January 1, 2008, and for each new
