### A BILL FOR AN ACT

RELATING TO SOLID WASTE MANAGEMENT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Hawaii's bottle law has proven to be an overwhelming success for Hawaii's environment, with over half a 2 billion bottles and cans being diverted from Hawaii's landfills. 3 The initiative has reduced litter, created employment, and 4 provided fundraising opportunities for schools and charities. 5 However, many consumers complain about the cumbersome redemption 6 process. Many elderly consumers, in particular, find the 7 redemption process burdensome, considering they may only have a 8 few bottles or cans to redeem, and would prefer to redeem the 9 beverage containers at a nearby dealer. 10

11 The purpose of this Act is to require dealers in high-12 density population areas to provide redemption to consumers. 13 The dealers can decide whether to subcontract with a certified 14 redemption center to operate on the dealer's premises or provide 15 a reverse vending machine pursuant to section 342G-115, Hawaii 16 Revised Statutes.
