### A BILL FOR AN ACT

RELATING TO CAREGIVING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The number of grandparents raising
- 2 grandchildren is growing rapidly, both statewide and nationwide.
- 3 According to the United States Census Bureau, between 1990 and
- 4 2000, there was an over thirty per cent increase in the number
- 5 of children under age eighteen living in grandparent-headed
- 6 households in Hawaii. Of the 14,029 grandparents in Hawaii who
- 7 report that they are responsible for their resident
- 8 grandchildren, over one-fifth also report that the children's
- 9 parents are not present in the household.
- 10 The rapid increase in the number of grandparents raising
- 11 grandchildren is attributed to both demographic trends and
- 12 social issues. Grandparents today have an increased life
- 13 expectancy and relative good health compared to previous
- 14 generations. As a result, they are better able to assume the
- 15 responsibilities of custodial caregiving. Broad social issues
- 16 such as, divorce, substance abuse, incarceration, mental
- 17 illness, and abuse or neglect of the grandchildren are amongst

- 1 the reasons that grandparents take the role of primary
- 2 caregivers from their children.
- 3 Custodial grandparenting has emotional, physical, and
- 4 financial costs. Grandparents often report feeling guilt or
- 5 shame resulting from the situations that lead to them acquiring
- 6 custody of their grandchildren. They report more anxiety,
- 7 depression, and physical health problems than their non-
- 8 caregiving peers. Many of these grandparents are single,
- 9 female, and living in poverty. Their problems are often
- 10 exacerbated if they do not have legal custody of their
- 11 grandchildren, as they may not receive financial or educational
- 12 support or health care for their grandchildren.
- 13 Custodial grandparents need accurate and accessible
- 14 information on a myriad of issues, including legal aid for
- 15 custody or guardianship, financial assistance, counseling,
- 16 respite care, housing, health care, and education regarding
- 17 parenting for the second time.
- 18 It is important to have a clear understanding of the issues
- 19 facing and the needs of grandparents raising grandchildren in
- 20 Hawaii in order to formulate policies and programs to better
- 21 assist this population.

- 1 SECTION 2. There is appropriated out of the general
- revenues of the State of Hawaii the sum of \$24,000, or so much 2
- 3 thereof as may be necessary for fiscal year 2007-2008, for the
- 4 executive office on aging to conduct an assessment of the issues
- facing, and the needs of, grandparents raising grandchildren in 5
- 6 Hawaii.
- 7 SECTION 3. The sum appropriated shall be expended by the
- 8 department of health for the purposes of this Act.
- 9 SECTION 4. The department of health shall report to the
- legislature no later than twenty days prior to the convening of 10
- the 2008 regular session on the actions taken pursuant to their 11
- 12 Act.

13 SECTION 5. This Act shall take effect on July 1, 2007.

#### Report Title:

Appropriation; Caregiving

#### Description:

Makes an appropriation to the department of health for an assessment of the issues facing, and the needs of, grandparents raising grandchildren in Hawaii.
