A BILL FOR AN ACT

RELATING TO FAMILY CAREGIVING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, due to a shortage 2 of care providers in Hawaii, family caregiving has become a 3 critical element of our health and long-term care system. By 4 2020, more than one in four individuals is expected to be sixty 5 years old or older. The need for personal care assistance due 6 to physical, sensory, cognitive, and self-care disabilities 7 increases with age. As Hawaii's population ages, many more 8 families will be providing higher levels of long-term care to frail and disabled older adults at home. 9

10 Family members who provide care to care recipients with chronic or disabling conditions are themselves at risk for 11 12 physical, emotional, and financial problems. The daily 13 challenges and health risks that family caregivers face can 14 impede the family caregiver's ability to provide care, lead to 15 higher health care costs, and affect the family caregiver's 16 quality of life and the quality of life of the care recipient. 17 A comprehensive public policy to strengthen support for

1 family caregivers is essential. A crucial element in the design 2 and implementation of a comprehensive public policy is an 3 assessment of the needs of family caregivers and the care 4 recipients who are age sixty and older with physical or 5 cognitive disabilities. A thorough needs assessment is 6 imperative to appropriately encourage, support, and strengthen 7 the provision of family careqiving. 8 The purpose of this Act is to strengthen support of family 9 careqiving by requiring the executive office on aging to conduct 10 a comprehensive assessment of care recipients' needs and the 11 needs of their family caregivers. 12 SECTION 2. (a) The executive office on aging shall 13 conduct a comprehensive assessment of the needs of care 14 recipients' who are age sixty and older with physical or 15 cognitive disabilities and the needs of their family caregivers. 16 The needs assessment should include an evaluation of: 17 The extent of the unmet caregiving needs of persons (1)18 age sixty and older with physical or cognitive 19 disabilities; 20 (2) The size of the current family caregiver population; 21 (3) The percentage of care recipients' needs being met by 22 paid versus unpaid caregivers; and 2007-0533 HB SMA-2.doc

1 (4) The impact of caregiving on family caregivers' 2 employment and income. 3 (b) In conducting the needs assessment, the executive 4 office on aging shall identify and review past surveys, such as 5 the 2003 Hawaii Health Survey, include focus groups, and develop policy questions to guide the focus of the needs assessment. 6 7 (C) In conducting the needs assessment, the executive 8 office on aging may utilize telephone surveys or other methods 9 of gathering reliable data regarding care recipients' needs and 10 the needs of their family caregivers, including purchasing 11 additional questions for the upcoming Hawaii Health Survey. 12 (d) The executive office on aging shall forward a copy of 13 the completed needs assessment to the joint legislative 14 committee on family careqiving no later than twenty days prior 15 to the convening of the 2008 regular legislative session to help 16 facilitate the development of a comprehensive, sustainable, and 17 community-based family caregiver support system. For purposes of this section, "family caregiver" means 18 (e) 19 a person, including a non-relative such as a friend or neighbor, who provides free and continuing day-to-day care in the home to 20

21 a care recipient.

SECTION 3. The executive office on aging shall submit a
 report, including the completed needs assessment and any
 proposed legislation, to the legislature no later than twenty
 days prior to the convening of the 2008 regular legislative
 session.

6 SECTION 4. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$, or so
8 much thereof as may be necessary for fiscal year 2007-2008, for
9 the executive office on aging to conduct a comprehensive needs
10 assessment pursuant to section 2.

11 The sum appropriated shall be expended by the department of 12 health for the purposes of this Act.

13 SECTION 5. This Act shall take effect upon its approval;14 provided that section 4 shall take effect on July 1, 2007.
