14		lands, in writing.
15	(b)	An owner who receives written notice pursuant to
16	subsection (a)(1) shall take immediate measures to mitigate the

3	(c) If an owner fails to mitigate a hazard pursuant to

8	associated with mitigating the hazard, including administrative

12	administrative fines, fees, and costs, including attorney's fees		
13	and costs, and payment for the cost to mitigate any hazard		
14	resulting from a violation of subsection (b).		
15	(f) The department shall adopt rules pursuant to chapter

Report Title: Real Property; Soil Erosion and Sediment Control

Description:

Permits the department of land and natural resources to obtain a warrant and enter privately owned real property to mitigate hazards posed by potential rock, soil, or other slope movement, and to charge the owner for the cost of mitigating the hazard.
