# HOUSE CONCURRENT RESOLUTION

---

URGING THE UNITED STATES ARMY TO CEASE LIVE-FIRE MILITARY  
TRAINING EXERCISES AT MAKUA MILITARY RESERVATION.

1 WHEREAS, Makua Valley, located near Kaena Point on the  
2 western coast of Oahu, is considered sacred by many native  
3 Hawaiians; and  
4

5 WHEREAS, Makua Military Reservation (Military Reservation),  
6 which is situated in Makua Valley, extends west from the  
7 ridgeline of the Waianae Mountains to the Pacific Ocean and is  
8 located approximately three miles north of the town of Makaha;  
9 and  
10

11 WHEREAS, the Military Reservation consists of 4,856 acres  
12 in a combination of fee simple, ceded, and leased lands; and  
13

14 WHEREAS, use of Makua Valley by the United States Army was  
15 first granted in May 1943 by the Territory of Hawaii through  
16 Revocable Permit No. 200; and  
17

18 WHEREAS, on August 17, 1964, President Lyndon B. Johnson  
19 signed Executive Order No. 11666 (Executive Order), which set  
20 aside for the use of the United States most of the area that  
21 composes the Military Reservation; and  
22

23 WHEREAS, with respect to the portion of the Military  
24 Reservation not set aside by the Executive Order, a lease  
25 agreement was entered into on August 17, 1964, between the  
26 Assistant Secretary of the Army and the Department of Land and  
27 Natural Resources of the State of Hawaii, whereby the United  
28 States government obtained control and use of the remaining area  
29 for a period of 65 years, a lease that ends in 2029; and



1 WHEREAS, the Military Reservation has been used extensively  
2 since 1943 as a live-fire training area and has been subjected  
3 to air bombing, ship-to-shore firing, amphibious operations, and  
4 live-firing of a variety of infantry and artillery weapons; and  
5

6 WHEREAS, Makua Valley contains sites of historical and  
7 archaeological value as well as endemic species of flora and  
8 fauna; and  
9

10 WHEREAS, the transport of live-fire weapons to and from the  
11 Military Reservation poses a danger to neighboring civilian  
12 communities; and  
13

14 WHEREAS, live-fire training exercises use toxic and  
15 hazardous chemicals and have ignited wildfires, causing  
16 significant damage to the environment; and  
17

18 WHEREAS, such live-fire training exercises also imperil  
19 important historical and archaeological areas; and  
20

21 WHEREAS, Makua Valley possesses cultural significance for  
22 native Hawaiians; and  
23

24 WHEREAS, according to Hawaiian principles of stewardship  
25 (kuleana), there is inherent reverence for the land as a living  
26 partner in the lives of people; now, therefore,  
27

28 BE IT RESOLVED by the House of Representatives of the  
29 Twenty-fourth Legislature of the State of Hawaii, Regular  
30 Session of 2007, the Senate concurring, that the United States  
31 Army is urged to cease immediately and permanently all live-fire  
32 training exercises at the Military Reservation; and

34 BE IT FURTHER RESOLVED that Hawaii's Congressional  
35 delegation is respectfully requested to introduce legislation  
36 requiring, and support efforts toward, the immediate and  
37 permanent cessation of all live-fire training exercises at the  
38 Military Reservation; and



1 BE IT FURTHER RESOLVED that certified copies of this  
2 Concurrent Resolution be transmitted to the President of the  
3 United States, Secretary of Defense, Secretary of the United  
4 States Army, Hawaii's Congressional delegation, Governor, and  
5 Department of Land and Natural Resources.
