
HOUSE CONCURRENT RESOLUTION

URGING THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN
DEVELOPMENT TO REMOVE DESIGNATED UNITS AT KALIHI VALLEY
HOMES FROM THE LIST OF STRUCTURES SCHEDULED FOR DEMOLITION
AND TO WORK WITH THE HAWAII PUBLIC HOUSING AUTHORITY TO
RENOVATE THE BUILDINGS INSTEAD.

1 WHEREAS, the most recent estimate of the total number of
2 homeless persons in Hawaii is 6,029 on any given day; and
3

4 WHEREAS, this number is a significant increase from the
5 last estimate in 1999, which was 3,171 on any given day; and
6

7 WHEREAS, the Hawaii Homeless Point-in-Time Study of 2003,
8 from which these estimates are derived, found that approximately
9 4,107 of these homeless persons are unsheltered; and
10

11 WHEREAS, this situation is indicative of the limited number
12 of shelter spaces available in the state; and
13

14 WHEREAS, Kalihi Valley contains the state's two largest
15 public housing projects, with over 4,000 individuals residing in
16 them; and
17

18 WHEREAS, Kalihi Valley Homes first opened in 1953 and
19 needed major renovations by the mid-1990s; and
20

21 WHEREAS, the demolition and disposition of public housing
22 is authorized under section 18 of the Housing Act of 1937, as
23 amended; and
24

25 WHEREAS, 72 units at Kalihi Valley Homes are currently
26 scheduled for demolition by the United States Department of
27 Housing and Urban Development; and



1 WHEREAS, renovating the existing units scheduled for
2 demolition would help replenish the inventory of public housing
3 more quickly than demolishing and reconstructing units
4 elsewhere; and


6 WHEREAS, the sole reason that the 72 units are scheduled
7 for demolition is to create more open space at Kalihi Valley
8 Homes; and
9

10 WHEREAS, given the high cost of demolition compared to the
11 lower cost of renovations, these structurally sound units should
12 be removed from the list of structures scheduled for demolition
13 to make public housing more readily available to the homeless in
14 Hawaii; now, therefore,
15

16 BE IT RESOLVED by the House of Representatives of the
17 Twenty-fourth Legislature of the State of Hawaii, Regular
18 Session of 2007, the Senate concurring, that the United States
19 Department of Housing and Urban Development is urged to remove
20 the 72 units at Kalihi Valley Homes from the list of structures
21 scheduled for demolition and to work with the Hawaii Public
22 Housing Authority to renovate the buildings instead; and

24 BE IT FURTHER RESOLVED that certified copies of this
25 Concurrent Resolution be transmitted to the Secretary of the
26 United States Department of Housing and Urban Development, the
27 Interim Executive Director of the Hawaii Public Housing
28 Authority, and each member of Hawaii's Congressional delegation.
