HOUSE CONCURRENT RESOLUTION

REQUESTING THE COUNTY OF MAUI TO INVENTORY ITS ROADS IN LIMBO.

1 2 3	WHEREAS, many government and homestead roads were created in the Territory of Hawaii; and
4 5 6	WHEREAS, after statehood, jurisdiction over some government and homestead roads was awarded to the counties; and
5 7 8 9	WHEREAS, many roads were also built by private entities for the benefit of the County of Maui and its people; and
10 11 12 13 14	WHEREAS, during that time, many roads became "roads in limbo", defined as roads that were laid out by government but are not part of the state road system and are not currently maintained by the county government; and
15 16 17 18 19	WHEREAS, roads in limbo also include roads that were developed by a private party but not properly conveyed to either the county, another private entity, or the state road system, and are not currently maintained by the county; and
19 20 21 22 23	WHEREAS, the roads in limbo that were transferred to the counties were never improved or upgraded to an acceptable standard, nor was funding provided for maintenance; and
24 25 26 27 28	WHEREAS, these roads have been an ongoing issue between the State, counties, and private entities, over who should be responsible for maintaining the roads and the associated costs of maintenance; and
29 30 31	WHEREAS, according to a 1989 Legislative Reference Bureau (LRB) Report, "The State and Counties have been at an impasse over this conflict, and neither side is willing to take

jurisdiction over these roads with their concomitant expense for 1 maintenance, upgrading and repair."; and 2 3 WHEREAS, the 1989 LRB Report further stated that the 4 standoff on the maintenance of the roads in limbo has "the 5 practical effect of leaving a significant number of roads in all 6 four Counties in substandard conditions and without routine 7 maintenance because no government body will accept 8 9 responsibility for them."; and 10 WHEREAS, people who need to use these roads suffer when 11 roadway jurisdiction is in dispute, as these roads are less 12 likely to be cared for than roads over which there was no 13 dispute; and 14 15 WHEREAS, laws have been enacted that dedicate all roads 16 that are not part of the State highway system to the counties, 17 thus these roads in limbo have been transferred to the counties; 18 19 and 20 WHEREAS, residents need to use these roads to access their 21 homes for which they pay property taxes to the county, and the 22 value of which the property tax is based is determined in part 23 by the condition of these roads; and 24 25 WHEREAS, Hui F Road in the County of Maui qualifies as one 26 of the roads in limbo which are in dire need of long-overdue 27 28 repair; and 29 WHEREAS, the County of Hawaii, in partnership with the 30 Hawaii island community, has undertaken a project to ascertain 31 an accurate inventory of the county's roads in limbo; now, 32 33 therefore, 34 BE IT RESOLVED by the House of Representatives of the 35 Twenty-fourth Legislature of the State of Hawaii, Regular 36 Session of 2007, the Senate concurring, that the County of Maui 37 in partnership with the community, is urged to inventory its 38 roads in limbo to properly establish jurisdiction of all roads 39 in the County of Maui; and 40 41
