## HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO DEFINE AND DISCLOSE  
THE LAND BOUNDARIES OF CAMPBELL HIGH SCHOOL, ILIMA  
INTERMEDIATE SCHOOL, KAIMILOA ELEMENTARY SCHOOL, AND  
POHAKEA ELEMENTARY SCHOOL, INCLUDING COMMON AREAS SHARED BY  
THE SCHOOLS.

1 WHEREAS, although James Campbell High, Ilima Intermediate,  
2 Kaimiloa Elementary, and Pohakea Elementary schools in the  
3 Leeward district have distinct campus boundaries, they also  
4 share common land areas; and

5  
6 WHEREAS, there is uncertainty among educational staff and  
7 administrators, parents, and community leaders about which areas  
8 are common areas, thus raising questions about the  
9 responsibility for the supervision of students using those  
10 areas, as well as the maintenance of those common grounds; and

11  
12 WHEREAS, various ingress and egress routes to the schools  
13 have reportedly been used as pass-through routes by non-  
14 registered visitors, students not enrolled at the schools, or  
15 members of the Ewa community, potentially creating situations  
16 that may threaten or endanger students at the schools; and

18 WHEREAS, parents, community leaders, and concerned Ewa  
19 residents want to deter truancy, prevent trespassing, and ensure  
20 student safety, which is compromised if unauthorized persons are  
21 able to access the school campuses; and

23 WHEREAS, the Ewa community has been unsuccessful in  
24 obtaining clear information from the Department of Education  
25 about individual school boundaries and common areas of the  
26 schools; now, therefore,

28 BE IT RESOLVED by the House of Representatives of the  
29 Twenty-fourth Legislature of the State of Hawaii, Regular



1 Session of 2007, the Senate concurring, that the Department of  
2 Education is requested to define and disclose the individual  
3 campus boundaries and common areas of the James Campbell High,  
4 Ilima Intermediate, Kaimiloa Elementary, and Pohakea Elementary  
5 schools; and

6  
7 BE IT FURTHER RESOLVED that each of the respective schools  
8 are requested to make the information about their schools'  
9 boundaries and common areas available to the public; and

11 BE IT FURTHER RESOLVED that certified copies of this  
12 Concurrent Resolution be transmitted to the Chairperson of the  
13 Board of Education, the Superintendent of Education, and the  
14 Chairperson of the Ewa Beach Neighborhood Board.
