
HOUSE CONCURRENT RESOLUTION

REQUESTING THE HAWAII HOUSING FINANCE AND DEVELOPMENT
CORPORATION, IN COLLABORATION WITH THE DEPARTMENT OF
BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM, TO CONDUCT A
STUDY ON HOUSING FOR ESSENTIAL WORKERS.

1 WHEREAS, Hawaii is in need of more affordable housing for
2 low- and moderate-income households; and
3

4 WHEREAS, the 2006 report of the Joint Legislative Housing
5 and Homeless Task Force established by Act 196, Session Laws of
6 Hawaii 2005, states that an estimated 44,190 housing units are
7 projected to be needed statewide between 2005-2009; and
8

9 WHEREAS, most essential workers, that is, teachers, police
10 officers, firefighters, and other emergency responders would be
11 considered moderate-income individuals; and
12

13 WHEREAS, even households and individuals with moderate
14 incomes have been priced out of Hawaii's housing market and are
15 sometimes forced to move out of state to achieve an improved
16 lifestyle and the possibility of homeownership; and
17

18 WHEREAS, additionally, the State and counties have
19 experienced difficulty in recruiting and retaining essential
20 workers, particularly when other states actively recruit in
21 Hawaii; and
22

23 WHEREAS, the primary expense of most households is housing;
24 and
25

26 WHEREAS, in addition to the cost of housing and the loss of
27 essential workers to other states, some rural areas of the state
28 have difficulty recruiting and retaining essential workers
29 because of the remote location and difficult commute; and



1 WHEREAS, providing affordable housing to Hawaii's essential
 2 workers would solve several problems, including improving
 3 retention of these workers; now, therefore,

4
 5 BE IT RESOLVED by the House of Representatives of the
 6 Twenty-fourth Legislature of the State of Hawaii, Regular
 7 Session of 2007, the Senate concurring, that the Hawaii Housing
 8 Finance and Development Corporation (HHFDC), in collaboration
 9 with the Department of Business, Economic Development, and
 10 Tourism, is requested to conduct a study on housing for
 11 essential workers; and

 13 BE IT FURTHER RESOLVED that the study should include, but
 14 not be limited to:

- 15
 16 (1) The possibility of providing affordable housing for
 17 essential workers;
 18
 19 (2) Creating a mortgage loan assistance or loan
 20 forgiveness program for essential workers;
 21
 22 (3) Providing incentives specifically for essential
 23 workers willing to work in a rural area experiencing
 24 shortages of those workers;
 25
 26 (4) Providing relocation costs; and
 27
 28 (5) Suggested legislation;

 32 BE IT FURTHER RESOLVED that certified copies of this
 33 Concurrent Resolution be transmitted to the Executive Director
 34 of HHFDC and the Director of Business, Economic Development, and
 35 Tourism.
