## HOUSE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A FINANCIAL AND MANAGEMENT  
AUDIT OF THE DEPARTMENT OF AGRICULTURE'S MANAGEMENT OF THE  
MOLOKAI IRRIGATION SYSTEM.

1 WHEREAS, the Board of Agriculture and the Department of  
2 Agriculture are charged with the maintenance and operation of  
3 the Molokai irrigation system, including, pursuant to section  
4 167-11, Hawaii Revised Statutes, the setting of all rates and  
5 charges; and  
6

7 WHEREAS, section 167-11, Hawaii Revised Statutes, grants  
8 the Board of Agriculture the power to fix and adjust rates and  
9 charges so the revenues derived therefrom shall be sufficient to  
10 cover the cost of operation, maintenance, replacement, any bond  
11 debt service, and other charges necessary to cover the capital  
12 cost of the system; and  
13

14 WHEREAS, those rates and charges for the Molokai irrigation  
15 system are set forth in section 4-152-22, Hawaii Administrative  
16 Rules (Department of Agriculture); and  
17

18 Whereas, the Department of Agriculture may be diverting  
19 some of the revenues it derives from the Molokai irrigation  
20 system to manage and maintain other irrigation systems it has  
21 under its jurisdiction or to support other department  
22 operations; and  
23

24 WHEREAS, the homesteaders and farmers who are users of the  
25 Molokai irrigation system are concerned that rates and charges  
26 for irrigation water that they are paying are being diverted to  
27 other uses when the Molokai irrigations system itself is in need  
28 of many capital and operational improvements; now, therefore,  
29

30 BE IT RESOLVED by the House of Representatives of the  
31 Twenty-fourth Legislature of the State of Hawaii, Regular



1 Session of 2007, the Senate concurring, that the Auditor is  
2 requested to conduct a financial and management audit of the  
3 Department of Agriculture's operation of the Molokai irrigation  
4 system; and

5  
6 BE IT FURTHER RESOLVED that the Auditor is requested to  
7 determine the following:

9 (1) The total annual revenues of the Molokai irrigation  
10 system for the last five years and projected revenues  
11 for the next three years;  
12  
13 (2) The total costs of operating and maintaining the  
14 Molokai irrigation system for the last five years and  
15 the projected costs for operation and maintenance for  
16 the next three years;  
17  
18 (3) The total capital improvement costs made for the  
19 Molokai irrigation system in the last five years and  
20 the projected or anticipated capital improvement costs  
21 that may be required in the next three years; and  
22  
23 (4) If any revenues from rates and charges charged to  
24 users of the Molokai irrigation system have been  
25 diverted to uses other than the operation and  
26 maintenance of the Molokai irrigation system; and  
27

28 BE IT FURTHER RESOLVED that the Auditor is requested to  
29 submit findings and recommendations, including any proposed  
30 legislation, to the Legislature not later than twenty days prior  
31 to the convening of the Regular Session of 2008; and  
32

33 BE IT FURTHER RESOLVED that certified copies of this  
34 Concurrent Resolution be transmitted to the Auditor, the  
35 Chairperson of the Board of Agriculture, and the Chairperson of  
36 the Molokai Irrigation System Water Users Advisory Board.
