HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION AND DEPARTMENT OF HEALTH TO COLLABORATE WITH THE ORGAN DONOR CENTER OF HAWAII TO INCREASE AWARENESS OF THE BENEFITS OF ORGAN DONATION IN THE STATE OF HAWAII.

1 WHEREAS, medical technology has advanced to the point where lives can be extended beyond what society had envisioned, even 2 3 as recently as twenty years ago; and 4 WHEREAS, individuals are given the opportunity to donate 5 6 their healthy organs to persons suffering from liver disease. kidney failure, lung injuries, and corneas for eyes; and 7 8 9 WHEREAS, tissues, bone, and other anatomical parts can also be used by those with injuries that require repair; and 10 11 12 WHEREAS, through the miracle of transplantation, many of our friends, neighbors, and family are now living healthy, 13 14 productive lives; and 15 WHEREAS, there are over 94,000 individuals on our nation's 16 organ transplant waitlist, and unfortunately, less than half of 17 potential donors will say "yes" to helping others through organ 18 or tissue donation; and 19 20 WHEREAS, 6,342 patients were removed from the national 21 waitlist for organ donation upon reaching their death in 2005; 22 23 and 24 25 WHEREAS, in Hawaii, 375 patients are currently waiting for life-saving organ transplants according to data provided by the 26 27 Organ Procurement and Transplant Network; and

WHEREAS, the need for donated organs and tissues continues 1 2 as there are thousands of people who would benefit if more individuals were to become organ and tissue donors; and 3 4 5 WHEREAS, to increase the number of available donors, greater efforts are needed to inform people of the "gift" of 6 7 organ and tissue donation and provide them with the opportunity of to save; and 8 9 10 WHEREAS, Hawaii has provided a clear and simple method to address this concern by allowing individuals to indicate on 11 12 their driver's license their willingness to be an organ donor; 13 and 14 15 WHEREAS, the Organ Donor Center of Hawaii is the only federally-designated, private, nonprofit, charitable 16 organization authorized to recover organs and tissue for 17 transplant in the State of Hawaii; thus, it should be given 18 19 greater assistance from public agencies in furthering this 20 wonderful initiative on multiple levels; and 21 WHEREAS, organ-donation education programs in high schools 22 23 have been proven effective in other states in providing clear information to students and dispelling false notions they may 24 25 have gained based on inaccuracies communicated through the 26 media; and 27 WHEREAS, the donation of an organ or tissue should not be 28 cost-prohibitive for those who choose to help; however, 29 unfortunately many individuals and families undergo financial 30 and emotional stress in the process of donating an organ or 31 32 tissue; and 33 WHEREAS, in 2004, the state of Wisconsin adopted what is 34 35 widely known as "Cody's Law," which was created to ease the financial burden organ or tissue donors bear by providing a tax 36 credit for expenses brought about through the organ or tissue 37 38 donation process; and 39 WHEREAS, taxable income costs of up to \$10,000 incurred by 40 individuals and families from donating all or part of a liver, 41 42 pancreas, kidney, intestine, lung, or bone marrow, and expenses 43 that include travel, lodging, and lost wages, are eligible for 44 this credit; and

WHEREAS, since its inception, Cody's Law has been adopted 1 2 in ten other states and is being considered in more than two 3 dozen others; and 4 5 WHEREAS, the Legislature, Department of Education, and Department of Health are ideally positioned to support the 6 7 efforts of those who seek to build an educated and healthy 8 Hawaii; now, therefore, 9 10 BE IT RESOLVED by the House of Representatives of the 11 Twenty-fourth Legislature of the State of Hawaii, Regular 12 Session of 2007, the Senate concurring, that the Department of 13 Education and Department of Health collaborate with the Organ Donor Center of Hawaii to increase awareness of the benefits of 14 15 organ and tissue donation in the State of Hawaii; and 16 17 BE IT FURTHER RESOLVED that the Department of Education. 18 Department of Health, and the Organ Donor Center of Hawaii 19 develop programs that: 20 21 (1)Provide clear and factual information to students to help them make an informed decision about 22 organ and tissue donation; 23 24 Provide a means for encouraging students to 25 (2) communicate their wishes about organ and tissue 26 donation to their families; and 27 28 29 (3) Ensure that students who will soon gain their driver's licenses will be presented with the 30 opportunity to become organ donors; 31 32 and 33 34 35 BE IT FURTHER RESOLVED that the Legislature supports living-donor programs such as Cody's Law, which provides 36 37 assistance when individuals are in the process of personally donating organs or tissue to save the lives of the ill; and 38
