HOUSE CONCURRENT RESOLUTION

URGING THE ADOPTION OF THE UNITED NATIONS' CONVENTION ON THE RIGHTS OF THE CHILD AS A GUIDELINE FOR ADDRESSING CONCERNS RELATED TO HAWAII'S KEIKI.

1 WHEREAS, in Hawaiian culture, the family is the central 2 aspect of society as expressed by the concept of ohana, and the 3 responsibilities and privileges of parenting, guardianship, and 4 advocacy for children are opportunities to enable a child's life 5 to be meaningful; and 6

7 WHEREAS, in Hawaii, the sustainability of the culture of
8 ohana is dependent upon making a child's safety and well-being a
9 priority when making decisions for development, transportation,
10 economic prosperity, or environmental wellness; and

12 WHEREAS, the principles of the Charter of the United 13 Nations affirm that the recognition of the inherent dignity and 14 the equal and inalienable rights of all members of the human 15 family is the foundation of freedom, justice, and peace in the 16 world; and

18 WHEREAS, the United Nations, in the Universal Declaration 19 of Human Rights and the International Covenants on Human Rights, 20 has affirmed that everyone is entitled to all the rights and 21 freedoms set forth therein, without distinction of any kind, 22 such as race, color, sex, language, religion, political or other 23 opinion, national or social origin, property, birth, or other 24 status; and

26 WHEREAS, the United Nations, in the Universal Declaration
27 of Human Rights, has proclaimed that each child is entitled to
28 special care and assistance; and

WHEREAS, the family, as the fundamental unit of society and 1 the natural environment for the growth and well-being of all its 2 members and particularly children, should be afforded the 3 necessary protection and assistance so that it can fully assume 4 5 its responsibilities with the community; and 6 7 WHEREAS, each child, for the full and harmonious 8 development of the child's personality, should grow up in a family environment, in an atmosphere of happiness, love, and 9 10 understanding; and 11 WHEREAS, to be fully prepared to participate as a member of 12 society, each child needs to be brought up in the spirit of the 13 ideals of the United Nations Charter, especially in the spirit 14 of peace, dignity, tolerance, freedom, equality, and solidarity; 15 16 and 17 18 WHEREAS, on November 20, 1989, the United Nations General 19 Assembly adopted the Convention of the Rights of the Child; and 20 21 WHEREAS, 192 nations have entered as signatories to the Convention of the Rights of the Child; and 22 23 24 WHEREAS, the preamble to the State of Hawaii Constitution proclaims that the State of Hawaii is dedicated to the 25 26 fulfillment of the State motto, "Ua mau ke ea o ka aina i ka pono," meaning, "The life of the land is perpetuated in 27 righteousness"; and 28 29 30 WHEREAS, to protect, nurture, and care for our keiki is an 31 underlying principle for Hawaii as a Pacific Island community; 32 and 33 34 WHEREAS, 13 percent of all Hawaii's children live in poverty; and 35 36 WHEREAS, 21 percent of the homeless are children age nine 37 38 or younger, and one out of three are age 17 or younger; and 39 40 WHEREAS, the Convention on the Rights of the Child contributes to awareness of the problems of children in Hawaii 41 42 and around the world; now, therefore,

BE IT RESOLVED by the House of Representatives of the
 Twenty-fourth Legislature of the State of Hawaii, Regular
 Session of 2007, the Senate concurring, that the Legislature
 urges the State of Hawaii to adopt the United Nations'
 Convention on the Rights of the Child as a guideline addressing
 concerns relating to Hawaii's keiki; and

8 BE IT FURTHER RESOLVED that the Legislature urges the
9 President to request that Congress ratify the Convention on the
10 Rights of the Child; and

12 BE IT FURTHER RESOLVED that certified copies of this 13 Concurrent Resolution be transmitted to the President of the 14 United States, the Governor, Attorney General, Director of 15 Finance, Superintendent of Education, Director of Health, 16 Director of Human Services, Director of Public Safety, and the 17 Chairperson of the Board of Regents of the University of Hawaii.
