HOUSE CONCURRENT RESOLUTION

REQUESTING THE SECRETARY OF THE INTERIOR TO ALLOW AND APPROVE THE ESTABLISHMENT OF A MEMORIAL AT A SUITABLE LOCATION WITHIN KALAUPAPA NATIONAL HISTORICAL PARK ON THE ISLAND OF MOLOKAI TO HONOR AND PERPETUATE THE MEMORY OF THOSE INDIVIDUALS WHO WERE FORCIBLY RELOCATED TO THE KALAUPAPA PENINSULA FROM 1866 TO 1969.

WHEREAS, from 1866 to 1969, people from Hawaii afflicted 1 with Hansen's disease were forced to relocate to the remote 2 northern Kalaupapa peninsula on the island of Molokai; and 3 4 WHEREAS, the churches of Siloama, established in 1866 and 5 St. Philomena, begun in 1872, and associated with the work of 6 Father Damien (Joseph DeVeuster) are located at Kalawao. Father 7 Damien's life and death among his people focused the attention 8 of the world on the problem of Hansen's disease and the plight 9 10 of its victims; and 11 WHEREAS, situated on the leeward side of the peninsula, 12 Kalaupapa Settlement is still home for several surviving 13 Hansen's disease patients whose memories and experiences are 14 cherished. Once a community in isolation, Kalaupapa now serves 15 as a place for education and contemplation and the site became a 16 national park in 1980 dedicated to preserving the memories and 17 18 lessons of the past; and 19 WHEREAS, Ka `Ohana O Kalaupapa is a nonprofit organization 20 consisting of patient residents at Kalaupapa National Historical 21 Park and their family members and friends; now, therefore, 22 23 BE IT RESOLVED by the House of Representatives of the 24 Twenty-fourth Legislature of the State of Hawaii, Regular 25 Session of 2007, the Senate concurring, that the Secretary of 26 the Interior is requested to allow and approve the establishment 27 of a memorial at a suitable location within Kalaupapa National 28

Historical Park by Ka `Ohana O Kalaupapa on the island of 1 Molokai to honor and perpetuate the memory of those individuals 2 who were forcibly relocated to the Kalaupapa peninsula from 1866 3 to 1969; and 4

BE IT FURTHER RESOLVED that the Secretary of the Interior 6 7 is requested to have the memorial display in an appropriate manner the names of the: 8

First five thousand individuals sent to the Kalaupapa (1) peninsula between 1866 and 1896, most of whom lived at Kalawao; and

(2) Approximately three thousand individuals who arrived at Kalaupapa in the second part of its history, when most of the community was concentrated on the Kalaupapa side of the peninsula; and

BE IT FURTHER RESOLVED that certified copies of this 19 Concurrent Resolution be transmitted to the President of the 20 United States and the Secretary of the Interior. 21
