WHEREAS, the Hawaii Disabilities Rights Center is the 1 designated agency under section 333F-8.5, Hawaii Revised 2 Statutes, to provide advocacy services to persons with 3 developmental disabilities and mental illness; and 4 5 WHEREAS, a designation of an agency such as the Hawaii 6 7 Disabilities Rights Center is a prerequisite for the State to receive federal funds; and 8 9 WHEREAS, Congress created a nationwide protection and 10 advocacy system for individuals with developmental disabilities 11 under the Developmental Disabilities Assistance and Bill of 12 Rights Act, as amended, to aid individuals with developmental 13 disabilities and their families so that they may gain access to 14 15 appropriate support and services; and 16 WHEREAS, the Hawaii Disabilities Rights Center has access 17 to all records of any person with developmental disabilities or 18 mental illness, to the extent required by federal law, as 19 provided in section 333F-8.5, Hawaii Revised Statutes; and 20 21 WHEREAS, the Department of Health has jurisdiction over 22 state funding for the Hawaii Disabilities Rights Center, and 23 pursuant thereto, has responsibility for the performance of the 24 Hawaii Disability Rights Center; and 25 26 WHEREAS, the Legislature is concerned about whether the 27 Hawaii Disabilities Rights Center is fulfilling its mission, 28 particularly since it also receives state funding; and 29 30 WHEREAS, the Hawaii Disabilities Rights Center has never 31 been the subject of an audit by the Auditor; and 32
