7 WHEREAS, standards for review of an application for any 8 construction, alternation, disposition, or improvement that will 9 affect any historic property should include consideration of the 10 historic significance and integrity of the individual building 11 and the overall impact to the historic context; and 12

13 WHEREAS, the State Historic Preservation Division, 14 Department of Land and Natural Resources, was established to 15 administer a comprehensive historic preservation program and 16 possesses the requisite knowledge, experience, and personnel to 17 review and evaluate the effect of proposed actions on historic 18 properties; now, therefore,

BE IT RESOLVED by the House of Representatives of the 20 Twenty-fourth Legislature of the State of Hawaii, Regular 21 Session of 2007, that the Department of Land and Natural 22 Resources, State Historic Preservation Division, is requested to 23 work with the Hawaii Historic Places Review Board, county 24 governments, the Historic Hawaii Foundation, and other 25 stakeholders to review chapter 6E, Hawaii Revised Statutes, with 26 respect to whether any changes should be made to that law with 27 regard to any proposed action that will affect any historic 28 property, regardless of whether the historic property is on the 29 Hawaii register of historic places, to ensure the intent and 30 public policy expressed in section 6E-1, Hawaii Revised 31 Statutes, is achieved; and 32 33

BE IT FURTHER RESOLVED that the Department of Land and Natural Resources, State Historic Preservation Division, is requested to submit findings and recommendations to the Legislature, including any proposed legislation, not later than twenty days prior to the convening of the Regular Session of 2008; and
