## HOUSE RESOLUTION

REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO STUDY OTHER STATES' ADULT PROTECTIVE SERVICES AND COMPARE THEM TO HAWAII'S ADULT PROTECTIVE SERVICES.

WHEREAS, the United States Senate Special Committee on 1 Aging has estimated that up to five million adults each year are 2 victims of neglect, exploitation, or other abuse; and 3 4 WHEREAS, other studies indicate that up to six per cent of 5 the national population of older adults has experienced some 6 type of abuse, neglect, or exploitation; and 7 8 WHEREAS, there is no national, uniform reporting system to 9 document the numbers of older Americans who experience abuse, so 10 the number of these individuals can only be estimated; and 11 12 WHEREAS, adult protective services are mandated for adult 13 victims of abuse in each of the fifty states and the District of 14 15 Columbia; and 16 WHEREAS, the eligible recipients of these services vary by 17 jurisdiction; and 18 19 WHEREAS, in most states, services are provided to any 20 vulnerable adult, while in other states the services are 21 provided only to individuals age sixty years and older or to 22 younger individuals with disabilities; and 23 24 WHEREAS, results of a recent Elder Abuse Incidence Study 25 shed light on a significant problem of elder abuse and neglect 26 among elders living in their own homes and who have gone largely 27 unidentified and unnoticed; and 28 29 WHEREAS, the study noted that only one in five new 30 incidents of abuse, neglect, or self-neglect are reported to 31 adult protective services agencies; and 32 33 WHEREAS, here in Hawaii, adult protective services provides 34 crisis intervention, investigation, and emergency services to 35

dependent adults who are reported to be abused, neglected, or 1 financially exploited by others or seriously endangered due to 2 self-neglect; and 3 4 WHEREAS, there are just over eighty-four thousand elders 5 that are seventy-five years or older in Hawaii; and 6 7 8 WHEREAS, national estimates of the frequency of abuse 9 towards this population range from five to ten per cent, which suggests that there may be four thousand or more cases of abuse 10 in Hawaii each year; and 11 12 WHEREAS, however, the Department of Human Services 13 indicates that in 2006, it investigated five hundred fourteen 14 cases, which suggests a large gap between those receiving 15 services and those possibly experiencing abuse; and 16 17 WHEREAS, there has been a great deal of discussion 18 regarding whether the Department of Human Services is serving 19 those who are most in need of adult protective services; and 20 21 WHEREAS, there has also been concern regarding whether any 22 changes to the current Adult Protective Services Law would 23 result in an increased case load and consequential strain on 24 case workers; now, therefore, 25 26 BE IT RESOLVED by the House of Representatives of the 27 Twenty-fourth Legislature of the State of Hawaii, Regular 28 Session of 2007, that the Legislative Reference Bureau is 29 requested to study other states' adult protective services and 30 compare them to Hawaii's adult protective services; and 31 32 BE IT FURTHER RESOLVED that in completing the study, the 33 Legislative Reference Bureau should: 34 35 (1) Examine the other states' adult protective services 36 laws and their implementation in the respective 37 states; 38 39 (2) Obtain information regarding the total number of cases 40 reported to the adult protective services of each 41 state and the ratio of cases per capita for each 42 43 state; 44 2007-2216 HR SMA.doc
