
HOUSE RESOLUTION

REQUESTING THE BOARD OF PROFESSIONAL ENGINEERS, ARCHITECTS,
SURVEYORS AND LANDSCAPE ARCHITECTS TO PROMOTE AWARENESS OF
FAMILY CAREGIVING NEEDS IN THE DESIGN OF NEW RESIDENCES.

1 WHEREAS, family caregiving has always been a universal
2 experience of all ethnicities, lifestyles, and income levels;
3 and
4

5 WHEREAS, due to a shortage of care providers in Hawaii,
6 family caregiving has become a critical element of our health
7 and long-term care system; and
8

9 WHEREAS, the need for personal care assistance due to
10 physical, sensory, cognitive, and self-care disabilities
11 increases with age; and
12

13 WHEREAS, by 2020, more than one in four individuals is
14 expected to be sixty years of age or older; and
15

16 WHEREAS, as Hawaii's population ages, many more families
17 will be providing higher levels of long-term care to frail and
18 disabled older adults at home; and
19

20 WHEREAS, the design of a residence can enhance or impede
21 the independence and mobility of its occupants as they age; and
22

23 WHEREAS, the design of a residence can also enhance or
24 impede a family caregiver's capacity to provide assistance to
25 frail and disabled older adults at home; and
26

27 WHEREAS, the National Academy of Science has recommended
28 that professional training in architecture include information
29 on the range of capabilities and limitations of the aging
30 population so that these factors can be incorporated into
31 designs; and

33 WHEREAS, certain physical attributes of housing can support
34 therapeutic activities and aging-in-place, such as the basic
35 partitioning of the building; and

2 WHEREAS, the Board of Professional Engineers, Architects,
3 Surveyors and Landscape Architects should promote awareness of
4 family caregiving needs in the design of new residences; now,
5 therefore,

7 BE IT RESOLVED by the House of Representatives of the
8 Twenty-fourth Legislature of the State of Hawaii, Regular
9 Session of 2007, that the Board of Professional Engineers,
10 Architects, Surveyors and Landscape Architects is requested to
11 promote awareness of family caregiving needs in the design of
12 new residences; and

14 BE IT FURTHER RESOLVED that certified copies of this
15 Resolution be transmitted to the Chair of the Board of
16 Professional Engineers, Architects, Surveyors and Landscape
17 Architects; and the Dean of the University of Hawaii at Manoa,
18 School of Architecture.
