## HOUSE RESOLUTION

---

REQUESTING THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND  
TOURISM, THE HAWAII TOURISM AUTHORITY, AND THE HAWAII  
VISITORS AND CONVENTION BUREAU TO CONDUCT ACTIVITIES TO  
INCREASE THE NUMBER OF VISITORS FROM TAIWAN.

1 WHEREAS, in 2006, 593,000 visitors from Taiwan arrived in  
2 the United States; and

3  
4 WHEREAS, Taiwan travelers to the United States represented  
5 only 6.8 per cent of the total outbound travelers from Taiwan;  
6 and

7  
8 WHEREAS, the United State's 6.8 per cent share of all  
9 outbound Taiwan travelers was less than the United State's 10.0  
10 per cent share of outbound Taiwan travelers in previous years;  
11 and

12  
13 WHEREAS, the number of Taiwanese visitors to Hawaii in 2006  
14 was not a significant percentage of all visitors, approximately  
15 15,450 visitors; and

16  
17 WHEREAS, data indicates that the Taiwan market may be a  
18 potential source of new visitors to Hawaii; and

19  
20 WHEREAS, diversification of the tourism markets from which  
21 Hawaii draws visitors is a logical and important public policy  
22 goal necessary to provide some protection for the State's  
23 economy; and

24  
25 WHEREAS, activities should be undertaken by the State and  
26 tourism industry to promote Hawaii as a destination for visitors  
27 from Taiwan; activities to promote travel from Taiwan to Hawaii  
28 would be especially appropriate since the peoples of Taiwan and  
29 Hawaii have much in common; now, therefore,

31 BE IT RESOLVED by the House of Representatives of the  
32 Twenty-fourth Legislature of the State of Hawaii, Regular  
33 Session of 2007, that the Department of Business, Economic



1 Development, and Tourism, the Hawaii Tourism Authority, and the  
2 Hawaii Visitors and Convention Bureau are requested to undertake  
3 activities to increase the number of visitors from Taiwan who  
4 travel to the State; and  
5

6 BE IT FURTHER RESOLVED that the Department of Business,  
7 Economic Development, and Tourism is requested to work with the  
8 appropriate United States government agencies to ease the travel  
9 requirements for visitors from Taiwan; and  
10

11 BE IT FURTHER RESOLVED that the Department of Business,  
12 Economic Development, and Tourism, the Hawaii Tourism Authority,  
13 and the Hawaii Visitors and Convention Bureau are requested to  
14 coordinate their efforts to increase the number of visitors from  
15 Taiwan to the maximum extent possible; and

17 BE IT FURTHER RESOLVED that certified copies of this  
18 Resolution be transmitted to the Director of Business, Economic  
19 Development, and Tourism, the Chairperson of the Hawaii Tourism  
20 Authority, the President of the Hawaii Visitors and Convention  
21 Bureau, and the Director General of the Taipei Economic and  
22 Cultural Office.
