
HOUSE RESOLUTION

URGING THE OFFICE OF HAWAIIAN AFFAIRS TO CONTINUE TO CONVENE A
TEMPORARY COMMISSION ON BIOPROSPECTING.

1 WHEREAS, the Twenty-third Legislature in 2006 adopted House
2 Concurrent Resolution No. 193, House Draft 1, requesting the
3 Governor to establish a temporary advisory commission on
4 bioprospecting, to be placed within the Office of Hawaiian
5 Affairs for administrative purposes only, to make
6 recommendations for policy development in the areas of:

 - 10 (2) Equitable benefit-sharing;

 - 12 (3) Bio-safety protocols;

 - 14 (4) A permitting and licensing process; and

19 WHEREAS, House Concurrent Resolution No. 193, House Draft
20 1, requested that the commission prepare a report of its
21 recommendations for submission to the Legislature and the
22 Governor not later than twenty days prior to the convening of
23 the Regular Session of 2007; and

25 WHEREAS, on January 3, 2007, the Office of the Governor
26 finalized and notified the Office of Hawaiian Affairs of the
27 gubernatorial appointments to the commission; and

29 WHEREAS, the Office of Hawaiian Affairs has started the
30 process of convening the commission, but additional time will be
31 needed for the commission to start up and to complete its work
32 in addressing House Concurrent Resolution No. 193, House Draft
