## A BILL FOR AN ACT

RELATING TO SCRAP DEALERS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 445-233, Hawaii Revised Statutes, is 2 amended to read as follows:
- 3 "§445-233 Statement required. (a) Every scrap dealer,
- 4 when the dealer purchases scrap within the State, shall obtain a
- 5 written statement signed by the seller [or the seller's agent]
- 6 certifying that the seller [or the seller's agent] has the
- 7 lawful right to sell and dispose of the scrap. This statement
- 8 shall also contain the seller's name; the seller's business or
- 9 residence address; the seller's occupation; a description,
- 10 including serial numbers and other identifying marks, when
- 11 practical, of every scrap; the amount received by the seller;
- 12 the date, time, and place of the sale; and the license number of
- 13 any vehicle used to deliver the property to the place of
- 14 purchase.
- 15 (b) If the scrap presented for purchase is copper, in
- 16 whole or in part, the seller shall provide a copy of a receipt
- 17 that describes, with particularity:



1	(1)	The exact item that is being offered for sale;
2	(2)	Who issued the receipt;
3	(3)	The date of sale of the item prior to the item being
4		offered to the scrap dealer; and
5	(4)	The price, if any, of the item when obtained by the
6		seller.
7	(c)	If a receipt is not available, the seller shall
8	provide t	o the scrap dealer a notarized declaration, describing
9	with part	icularity:
10	(1)	The exact item that is being offered for sale;
11	(2)	Who sold or otherwise transferred the item to the
12		seller;
13	(3)	The date of sale of the item; and
14	(4)	The price, if any, of the item when obtained by the
15		seller.
16	<u>(d)</u>	If the seller does not provide a copy of the receipt
17	or the no	tarized declaration as required by subsections (b) and
18	(c), the	scrap dealer shall not purchase the copper, in whole or
19	in part,	and shall report the attempted sale to the police.
20	<u>(e)</u>	If the scrap dealer purchases any copper, in whole or
21	in part,	the scrap dealer shall take a photograph or photographs

of all of the copper offered for sale.

- 1 (f) The scrap dealer shall also require the seller to 2 verify the seller's identity by presenting [proper] a valid 3 photo identification[-] card or license issued by a federal or 4 state government agency authorized to issue such identification. 5 If the scrap being offered for sale is copper, in whole or in 6 part, the scrap dealer shall: 7 (1) Take a photograph of the seller; or 8 (2) Make a photocopy of the identification card or 9 license of the seller; 10 The scrap dealer shall keep at the dealer's place of (g) 11 business the signed written statement, the receipt or notarized 12 declaration required by subsection (b) and (c), the photographs 13 required by subsection (e), and the photocopy of the 14 identification card or license and photograph of the seller 15 required by subsection (f), if applicable, from the seller for a 16 period of two years after the date of purchase and the 17 statement, the receipt or notarized declaration required by 18 subsection (b) and (c), the photographs required by subsection 19 (e), and the photocopy and photograph required by subsection 20 (f), if applicable, may be examined at any time by the treasurer 21 [or], the chief of police[-], the attorney general, the 22 prosecuting attorney, or their designees.

1	(h)	Public utilities, as defined in section 269-1, shall	
2	be exempt	from the requirements of subsections (b) and (c).	
3	When the	seller is a public utility, the scrap dealer shall not	
4	be required to obtain the statement required by subsection (a)		
5	and it shall not be prohibited by subsection (d) from purchasing		
6	the copper from the public utility."		
7	SECTION 2. Section 445-235, Hawaii Revised Statutes, is		
8	amended to read as follows:		
9	<b>"§44</b>	5-235 Prohibitions; penalty. Any person who violates	
10	sections	445-232 [ <del>and</del> ], 445-233, or any person who falsifies a	
11	statement required by section 445-233, shall be guilty of a		
12	misdemean	or[ $\div$ ] and shall be sentenced in accordance with chapter	
13	706, exce	pt that the court shall impose a minimum sentence of:	
14	(1)	A fine of \$1,000 for the first offense;	
15	(2)	A fine of \$3,000 for the second offense;	
16	(3)	A fine of \$5,000 and the suspension of the scrap	
17		dealer's license for a period of six months for the	
18		third offense; provided that if the third offense	
19		occurs with a five-year period of the first offense	
20		the scrap dealer shall be subject to license	
21		revocation."

- 2 that matured, penalties that were incurred, and proceedings that
- 3 were begun before its effective date.
- 4 SECTION 4. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 5. This Act shall take effect on January 1, 2112,
- 7 and shall be repealed on July 1, 2009; provided that sections
- 8 445-233 and 445-235, Hawaii Revised Statutes, shall be reenacted
- 9 in the form in which they read on the day before the effective
- 10 date of this Act.
