## A BILL FOR AN ACT

RELATING TO AUTOMATED EXTERNAL DEFIBRILLATORS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 453-2, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 "(b) Nothing herein shall: Apply to so-called Christian Scientists so long as (1) 5 they merely practice the religious tenets of their church without pretending a knowledge of medicine or surgery; Prohibit service in the case of emergency or the (2) domestic administration of family remedies; 9 10 Apply to any commissioned medical officer in the (3) United States armed forces or public health service 11 engaged in the discharge of one's official duty, nor 12 13 to any practitioner of medicine and surgery from another state when in actual consultation, including 14 but not limited to  $[\tau]$  in-person, mail, electronic, 15 telephonic, fiber-optic, or other telemedicine 16 17 consultation with a licensed physician of this State, 18 if the physician from another state at the time of

1		such consultation is licensed to practice in the state
2		in which the physician resides; provided that:
3		(A) The physician from another state shall not open
4		an office, or appoint a place to meet patients,
5		or receive calls within the limits of the State;

7		(B) The licensed physician of this State retains
8		control and remains responsible for the provision
9	e e	of care for the patient; and
10		provided further that the laws and regulations
11		relating to contagious diseases are not violated;
12	(4)	Prohibit services rendered by any person certified
13		under part II of this chapter to provide emergency
14		medical services, or any physician assistant, when the
15		services are rendered under the direction and control
16		of a physician licensed in this State except for final

oculist or optometrist duly licensed by the State. The direction and control shall not be construed in every case to require the personal presence of the supervising and controlling physician. Any physician

17		external defibrillator program" means an

- 14 [shall have the meaning provided in section 453-2(b)(5)(B).]
- 15 means an appropriate training course that includes
- 16 cardiopulmonary resuscitation and proficiency in the use of an
- 17 automated external defibrillator.
- "Good faith" includes but is not limited to a reasonable
- 19 opinion that the immediacy of the situation is such that the
- 20 rendering of care should not be postponed.
- 21 "Rescue team" means a special group of physicians, basic
- 22 life support personnel, advanced life support personnel,

- 1 surgeons, nurses, volunteers, or employees of the owners or
- 2 operators of the hospital or authorized emergency vehicle who
- 3 have been trained in basic or advanced life support and have
- 4 been designated by the owners or operators of the hospital or
- 5 authorized emergency vehicle to attempt to provide such support
- 6 and resuscitate persons who are in immediate danger of loss of
- 7 life in cases of emergency."
- 8 SECTION 4. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 5. This Act shall take effect upon its approval.
