BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 206E-14, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows: 2 In the case of residential projects or redevelopment 3 4 projects, the terms of the sale shall provide for the repurchase 5 of the property by the authority at its option, in the event that the purchaser, if other than a state agency, desires to 6 7 sell the property [within ten years,]; provided that this requirement may be waived by the authority if the authority 8 determines that a waiver will not be contrary to the community 9 10 development plan. The authority shall establish at the time of 11 original sale a formula setting forth a basis for a repurchase 12 price based on market considerations, including but not being limited to interest rates, land values, construction costs, and 13 federal tax laws. 14 15 If the purchaser in a residential project is a state 16 agency, the authority may include as a term of the sale a provision for the repurchase of the property in conformance with 17
