# A BILL FOR AN ACT

RELATING TO TOBACCO.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 328J-16, Hawaii Revised Statutes, is
 amended as follows:

- 3 1. By amending the title and subsection (a) to read as

5 "[{]§328J-16[}] Cigarette sales from vending machines

6 self-service displays, and by lunch wagons prohibited. (a) The

7 sale or distribution [at no charge] of cigarettes by the

8 following methods is prohibited:

9 (1) From cigarette vending machines, unless the vending
10 machine is located in a bar, cabaret, or any
11 establishment for which the minimum age for admission

12 is eighteen; [<del>or</del>]

- 13 (2) From a lunch wagon engaging in any sales activity
  14 within one thousand feet of any public or private
  15 elementary or secondary school grounds [-]; or
- 16 (3) From a self-service display, except a cigarette
- 17 vending machine as provided in this subsection."

3	"Cigarette vending machine" means a self-service device

7	tobacco through the operation of a device that requires a
8	salesperson to control the dispensation of the product.
9	"Lunch wagon" means a mobile vehicle designed and
10	constructed to transport food and from which food is sold to the
11	general public and includes but is not limited to manapua
12	trucks.
13	"Self-service display" means a display that contains
14	cigarettes and other tobacco products and is located in an area
15	openly accessible to customers and from which customers can
16	readily access cigarettes and other tobacco products without the
17	assistance of a salesperson. A display case that holds
18	cigarettes from behind locked doors shall not constitute a self-
19	service display for purposes of this section.
20	"Sell" or "sale" means to solicit and receive an order for;
21	to have, keep, offer, or expose for sale; to deliver for value
