## A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Hawaii health commission; establishment. (a)
- 2 There is established within the department of budget and finance
- 3 for administrative purposes the Hawaii health commission. The
- 4 commission shall be an autonomous public body corporate and
- 5 politic and an instrumentality of the State.
- 6 (b) The commission shall be composed of nine members
- 7 appointed by the governor as provided in section 26-34; provided
- 8 that three members shall be appointed from a list of nominees
- 9 submitted by the speaker of the house of representatives and
- 10 three members shall be appointed from a list of nominees
- 11 submitted by the president of the senate. All members shall be
- 12 appointed for terms of four years each.
- (c) An executive director shall be selected by the
- 14 members.
- 15 (d) Each member shall hold office until the member's
- 16 successor is appointed and qualified.
