## A BILL FOR AN ACT

RELATING TO COURT INTERPRETERS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Federal laws require the state judiciary to provide language interpretation services to court users who are
- 3 limited-English proficient, deaf, or hard-of-hearing. The court
- 4 interpreter program does not presently include court interpreter
- 5 certification training or testing. The legislature finds that a
- 6 state court interpreter certification program will permit
- 7 identification of the best-qualified language interpreters
- 8 through appropriate screening and testing. Such a state court
- 9 interpreter certification program will also help to protect the
- 10 rights of those court users who are limited-English proficient,
- 11 deaf, or hard-of-hearing.
- 12 The purpose of this Act is to require the judiciary to
- 13 establish and implement a state court interpreter certification
- 14 program, and to appoint and use certified court interpreters in
- 15 legal proceedings.

- 1 SECTION 2. Chapter 606, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . INTERPRETERS
- 5 "§606- Policy; intent. It is the policy of this State
- 6 to ensure that persons who are limited-English proficient, deaf,
- 7 or hard-of-hearing, and who are unable to understand or
- 8 communicate adequately in the English language, are provided
- 9 interpreters when they appear or are involved in legal
- 10 proceedings.
- It is the intent of this part to provide for the
- 12 certification, appointment, and use of interpreters to secure
- 13 the rights of individuals who are limited-English proficient,
- 14 deaf, or hard-of-hearing in all legal proceedings as defined by
- 15 this part.
- 16 §606- Definitions. As used in this chapter:
- 17 "Appointing authority" means a trial judge, administrative
- 18 hearing officer, or other officer authorized by law to conduct
- 19 legal proceedings within the jurisdiction of the judiciary.
- 20 "Certified interpreter" means a person who holds a valid
- 21 certificate as a certified court interpreter issued by the
- 22 judiciary or an American sign language interpreter who is:

4	(2)	Certified by the Hawaii quality assurance system at

6	"Legal proceeding" means a civil, criminal, or an	
7	administrative proceeding within the jurisdiction of the	
8	judiciary.	
9	"Limited-English proficient" refers to a person's limited	
10	ability to speak, read, or understand the English language. For	
11	purposes of this part, a limited-English proficient court user	
12	or individual is a principal party in interest or witness	
13	participating in a legal proceeding.	
14	"Principal party in interest" means a person involved in a	
15	legal proceeding who is a named party, who will be bound by the	
16	decision or action, or who is foreclosed from pursuing the	
17	person's rights by the decision or action that may be taken in	
18	the proceeding.	
19	"Witness" means anyone who testifies in any legal	
20	proceeding.

- 5 §606- Cost of interpreting services. Compensation for
- 6 services of interpreters shall be determined by a schedule of
- 7 fees adopted by the judiciary. Interpreters shall be paid in
- 8 such manner as the judiciary may determine, subject to the
- 9 necessary funds being appropriated, granted, or provided for
- 10 this purpose."
- 11 SECTION 3. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ , or so much
- 13 thereof as may be necessary for fiscal year 2007-2008, and the
- 14 same sum, or so much thereof as may be necessary for fiscal year
- 15 2008-2009, for the office of the administrative director of the
- 16 courts to establish, implement, and operate a statewide program
- 17 for interpreter training, qualification, certification,
- 18 professional conduct, and discipline.
- 19 The sums appropriated shall be expended by the judiciary
- 20 for the purposes of this Act.
- 21 SECTION 4. If any provision of this Act, or the
- 22 application thereof to any person or circumstance is held

- 1 invalid, the invalidity does not affect other provisions or
- 2 applications of the Act, which can be given effect without the
- 3 invalid provision or application, and to this end the provisions
- 4 of this Act are severable.
- 5 SECTION 5. This Act shall take effect on July 1, 2008;
- 6 provided that section 3 of this Act shall take effect on July 1,
- 7 2007.
