### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to provide financial 2 support to the department of land and natural resources for the necessary staff and equipment that is required to execute the 3 duties established in this Act. 4 5 SECTION 2. Section 6E-43.5, Hawaii Revised Statutes, is 6 amended by amending subsection (e) to read as follows: 7 "(e) Department records relating to the location and description of historic sites, including burial sites, 8 9 inadvertently discovered human remains, and sites of relocated 10 burials or human remains, if deemed sensitive by a council or 11 the Hawaii historic places review board, shall be confidential." 12 SECTION 3. Section 6E-43.6, Hawaii Revised Statutes, is amended as follows: 13 14 1. By amending subsection (b) to read: The discovery shall be reported as soon as possible 15 "(b) 16 to the department, the appropriate medical examiner or coroner,

               In cases where remains are archaeologically removed,

    the department shall determine the place of relocation, after

    identified lineal descendants, as appropriate. The department

    shall also map the coordinates of the location where the human

    skeletal remains are to be relocated, or preserved in place,

    using a global positioning system device, and retain a record of

    the information; provided that the location shall remain

    confidential except as to any lineal or cultural descendants.

    Relocation shall conform with requirements imposed by the
17
    department of health, and may be accompanied by traditional

    ceremonies, as determined by the lineal descendants, or, if no

- 3 SECTION 4. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ , or so
- 5 much thereof as may be necessary for fiscal year 2007-2008, for
- 6 staff and equipment costs to fulfill the duties set forth in

#### REPORT Title:

Burial Sites; Location Recordation; Appropriation

### Description:

Requires the Department of Land and Natural Resources to map burial sites that are inadvertently discovered using a global positioning system device and retain records of the location of the site and the site to which the remains are reinterred, if any, keeping the relocation site confidential except as to lineal or cultural descendants. Appropriates \$ for the 2007-2008 fiscal year for staff and equipment necessary to fulfill these requirements. (SD2)
