A BILL FOR AN ACT

RELATING TO THE ISLAND OF KAHO'OLAWE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 340, Session Laws of Hawaii, 1993, mandates
- 2 that the island of Kaho'olawe be reserved in perpetuity for uses
- 3 such as the preservation and practice of rights customarily and
- 4 traditionally exercised by native Hawaiians for cultural,
- 5 spiritual, and subsistence purposes; the preservation and
- 6 protection of the island's archaeological, historical, and
- 7 environmental resources; and education. The Kaho'olawe island
- 8 reserve commission plans to establish kahua kauhale or culture
- 9 and education centers, operations facilities, overnight
- 10 campsites, restoration areas, and cultural and wildlife
- 11 preserves on the island.
- 12 Concerns have emerged regarding whether appropriate power
- 13 sources and adequate fuel supplies exist to successfully
- 14 maintain planned facilities and operations because Kaho'olawe is
- 15 geographically and logistically isolated from the other Hawaiian
- 16 islands.

1	The use of alternative energy resources for the island's
2	power needs is advisable and in keeping with the Kaho'olawe
3	island reserve commission's mandate and vision to restore,
4	preserve, and maintain a pristine natural environment on the
5	island. Kaho'olawe can serve as a model project for
6	sustainability and alternative energy research and application.
7	The state planning act, chapter 226, Hawaii Revised Statutes,
8	identifies increased energy self-sufficiency as one of the
9	State's energy objectives.
10	The purpose of this Act is to appropriate funds to:
11	(1) Design, plan, and install renewable energy systems for
12	a model kahua kauhale that will:
13	(A) Support large group or longer-term visits to the
14	island to introduce visitors to the island and
15	for apprenticeship, project specific uses, and
16	restorative activities;
17	(B) Serve as a model to determine energy and
18	logistical requirements of future kahua kauhale;
19	and
20	(2) Enable ongoing evaluation of alternative energy
21	applications to support the future vision and
22	activities for the island of Kaho'olawe.

1	SECTION 2. There is appropriated out of the general *
2	revenues of the State of Hawaii the sum of \$1,000,000, or so
3	much thereof as may be necessary for fiscal year 2007-2008, and
4	the same sum, or so much thereof as may be necessary for fiscal
5	year 2008-2009, for the following purposes:
6	(1) \$800,000 for the design, purchase, and installation of
7	renewable energy systems and the costs of transporting
8	related equipment for a kahua kauhale (educational and
9	cultural center and work camp) that will be used as a
10	model encampment on the island of Kaho'olawe; and
11	(2) The ongoing evaluation of long-term alternative energy
12	applications to support the future vision and
13	historical, cultural, archeological, and restorative
14	activities for the island of Kaho'olawe, including an
15	evaluation of the feasibility of using renewable
16	resource options for pumping of fresh water,
17	desalinization, ice production, and fuel for vehicles
18	SECTION 3. The sums appropriated shall be expended by the
19	Kaho'olawe island reserve commission for the purposes of this
20	Act.
