### A BILL FOR AN ACT

RELATING TO POLYBROMINATED DIPHENYL ETHERS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that polybrominated
- 2 diphenyl ethers, particularly decabromo diphenyl ether, is the
- 3 most widely used brominated flame retardant in the United
- 4 States. Decabromo diphenyl ether is used predominantly in
- 5 furniture and hard plastic consumer products.
- 6 Chapter 332D, Hawaii Revised Statutes, relating to
- 7 polybrominated diphenyl ethers, includes two of the three
- 8 primary forms of commercial mixtures. Decabromo diphenyl ether
- 9 was not included in the original or in the conference draft of
- 10 H.B. No. 2013, enacted by Act 146, Session Laws of Hawaii 2004,
- 11 relating to polybrominated diphenyl ethers.
- 12 The purpose of this Act is to:
- 13 (1) Add decabromo diphenyl ether to the prohibition on
- manufacture or distribution of polybrominated diphenyl
- ethers, beginning January 1, 2009; and

1	(2) Require the department of health to study whether
2	there is a suitably safe alternative to the use of
3	decabromo diphenyl ether.
4	SECTION 2. Section 332D-1, Hawaii Revised Statutes, is
5	amended by adding three new definitions to be appropriately
6	inserted and to read as follows:
7	"Commercial decabromo diphenyl ether" or "commercial"
8	deca-bde" means the chemical mixture of decabromo diphenyl
9	ether, including associated polybrominated diphenyl ether
10	impurities not intentionally added.
11	"DBDPE" means decabromo diphenyl ether.
12	"Electronic enclosure" means the plastic housing that
13	encloses the components of electronic products, including but
14	not limited to, televisions and computers."
15	SECTION 3. Chapter 332D, Hawaii Revised Statutes, is
16	amended by adding a new section to be appropriately designated
17	and to read as follows:
18	"§332D- Restriction on manufacture or distribution of
19	commercial DBDPE. (a) Beginning January 1, 2009, a person
20	shall not manufacture, process, or distribute in commerce
21	residential upholstered furniture, or any televisions or

- 1 computer that has an electronic enclosure containing commercial
- 2 DBDPE or commercial deca-bde.
- 3 (b) Violation of this section shall be subject to a civil
- 4 fine of \$1,000 for each individual furniture, television, or
- 5 computer.
- 6 (c) The department of health shall adopt rules pursuant to
- 7 chapter 91 to enforce this section."
- 8 SECTION 4. The department of health shall undertake to
- 9 study whether there is an effective flame retardant, available
- 10 by January 1, 2009, that is a safer product than one containing
- 11 decabromo diphenyl ether and that is technically feasible to use
- 12 in residential upholstered furniture, or televisions, or
- 13 computers. If no safer product is available, or if any safer
- 14 product is in violation of any county fire code, the department
- 15 of health shall not enforce section 3 of this Act until such
- 16 time as a safer product is available that meets county fire
- 17 code. The department of health shall give public notice in
- 18 accordance with section 1-28.5, Hawaii Revised Statutes, when it
- 19 commences enforcement of section 3 of this Act pursuant to a
- 20 safer product being found.
