## A BILL FOR AN ACT

RELATING TO HAWAIIAN LANGUAGE.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that the Constitution of the State of Hawai'i provides for the preservation and promotion
- 3 of native Hawaiian culture, history, and language. For example,
- 4 article X, section 4, provides that, "[t]he State shall promote
- 5 the study of Hawaiian culture, history and language." Article
- 6 XIII, section 7, Constitution of the State of Hawai`i, provides,
- 7 "[T]he State reaffirms and shall protect all rights, customarily
- $oldsymbol{8}$  and traditionally exercised for subsistence, cultural and
- 9 religious purposes" of native Hawaiians. Because maintaining a
- 10 living language is an integral component of preserving a
- 11 culture, it is also important to note that article XV,
- 12 section 4, of the Constitution of the State of Hawai'i,
- 13 reestablishes that "English and Hawaiian shall be the official
- 14 languages of Hawaii."
- 15 Since 1978, when the State reaffirmed Hawaiian as one of
- 16 its official languages, the legislature has backed efforts to
- 17 incorporate the language into official state writings, emblems,

- 1 and signs. Ensuring that these public inscriptions are
- 2 mandatory, accurate, and spelled correctly and use the proper
- 3 Hawaiian macrons and glottal stops not only shows the deserved
- 4 respect for the native language of these islands, but also fully
- 5 comports with the intent and words of the state constitution.
- 6 The purpose of this Act is to ensure the constitutionally
- 7 and ethically mandated preservation of the native Hawaiian
- 8 language and culture by requiring that all state and county
- 9 letterheads, when newly created or reprinted, contain the
- 10 accurate, appropriate, and authentic Hawaiian names and language
- 11 printed above the English translations.
- 12 SECTION 2. Section 1-13.5, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- "[{]\$1-13.5[}] Hawaiian language; letterheads; spelling.
- 15 [Macrons and glottal stops may be used in the spelling of words
- 16 or terms in the Hawaiian language in] All letterheads for
- 17 documents prepared by or [for] on behalf of state or county
- 18 agencies or officials[-] shall include in the letterhead, if the
- 19 letterhead contains Hawaiian names or language, the accurate,
- 20 appropriate, and authentic Hawaiian names and language,
- 21 including proper Hawaiian punctuation, spelling, macrons, and
- 22 glottal stops, printed above the English translation; provided

- 1 that this requirement shall not apply to a letterhead existing
- 2 on the effective date of this Act until a replacement for the
- 3 letterhead is required; and provided further that this
- 4 requirement shall not apply to state artwork or to the hanging
- 5 state emblem in the rotunda of the state capitol. Any rule,
- 6 order, policy, or other act, official or otherwise, that
- 7 prohibits or discourages the use of these symbols shall be
- 8 void."
- 9 SECTION 3. Section 5-6.5, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "[+]\$5-6.5[+] State language. The Hawaiian language is
- 12 the native language of [Hawaii] Hawaii and [may] shall be used
- 13 on all emblems and symbols representative of the State, its
- 14 departments, agencies, and political subdivisions[-]; provided
- 15 that this requirement shall not apply to state or county
- 16 letterheads containing Hawaiian names or language and existing
- 17 on the effective date of this Act until a replacement for the
- 18 letterhead is required."
- 19 SECTION 4. Hawaiian language interim task force. (a)
- 20 There is established the Hawaiian language interim task force,
- 21 to be administratively attached to the department of accounting
- 22 and general services, for the purpose of developing an

14		by the speaker of the house of representatives. The
15		representative from the Bishop Museum shall serve as
16		chair of the task force.
17	(b)	The appointments shall be made and the task force
18	shall be	convened no later than August 1, 2007. The task force
19	shall dev	elop an implementation plan and identify an official
20	Hawaiian	language authority that shall be considered the
21	official	reference to be used by state and county agencies in
22	the implem	mentation of this Act. In selecting an official

- 6 (c) The members of the task force shall not receive
- 7 compensation for their service, but may be reimbursed for
- 8 reasonable expenses, including travel expenses, incurred in the
- 9 performance of their task force duties.
- (d) The task force shall submit to the legislature, the
- 11 governor, and the mayors of the respective counties a report,
- 12 including the implementation plan adopted pursuant to this Act,
- 13 no later than twenty days prior to the convening of the 2008
- 14 regular session. The report shall include:
- 15 (1) The identification of resources necessary for the
- implementation of this Act, including information
- technology software and the costs of the software;
- 18 (2) A recommendation on official references for state and
- 19 county officials to use to incorporate accurate,
- appropriate, and authentic Hawaiian names,
- 21 punctuation, spelling, and macrons and glottal stops

    to exist on July 1, 2008.
         SECTION 5. There is appropriated out of the general

    revenues of the State of Hawai'i the sum of $ , or so much

    establishment of the Hawaiian language interim task force.

         The sum appropriated shall be expended by the department of
