### A BILL FOR AN ACT

RELATING TO HEALTH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the chemical and radiological toxicity of depleted uranium has been a reported 2 cause of kidney dysfunction, lung damage, neurological 3 disorders, liver infection, and high miscarriage rates among 4 5 military personnel. These health problems have been reported from military personnel who have served in designated combat 6 zones where depleted uranium munitions and armor have been used, 7 including the 1991 Gulf War and during the three years since the 8 9 2003 invasion of Iraq. 10 The legislature further finds that the military use and disposal of depleted uranium munitions are capable of having a 11 12 significant environmental impact, and depleted uranium has been 13 found in contaminated ground surfaces that lead to food and 14 ground water contamination.
- The purpose of this Act is to provide access for all
  returning veterans to a best practices health screening test for
  exposure to depleted uranium and to take steps to evaluate the
  scope and adequacy of storage and disposal of depleted uranium

- the governor as nominated by the director of veterans' 1 services. 2 The task force shall study the effects of depleted 3 uranium as it relates to veterans in the State and develop a 5 plan for outreach and follow up for veterans who have been exposed to depleted uranium and who have developed adverse 6 health effects due to their exposure. 8 (d) The task force shall report its findings and 9 recommendations to the legislature no later than twenty days prior to the convening of the regular session of 2008. 10 (e) The task force shall cease to operate on January 1, 11 12 2008. SECTION 4. (a) The department of health shall conduct an 13 environmental assessment of the scope and adequacy of depleted 14 15 uranium storage and disposal in Hawaii and compile a report on 16 training received by members of the armed forces on exposure to 17 depleted uranium. The department shall report its findings and 18 recommendations to the legislature no later than twenty days 19 20 prior to the convening of the regular session of 2008. 21 SECTION 5. There is appropriated out of the general
