## A BILL FOR AN ACT

RELATING TO CABLE TELEVISION SYSTEMS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 440G, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§440G- Designation of access organizations;
5	<b>requirements.</b> (a) The director may designate an access
6	organization to oversee the development, operation, supervision,
7	management, production, or broadcasting of programs for any
8	channels obtained under section 440G-8.
9	(b) The director shall establish the requirements for the
10	designation of an access organization pursuant rules adopted
11	under chapter 91.
12	(c) The director shall ensure that the terms and
13	conditions upon which requirements for the designation is
14	provided are fair to the public, taking into account the
15	geographic, topographic, and economic characteristics of the
16	service area and the economics of providing cable access in the
17	service area.

1	(d) Any decision designating, modifying, or rescinding a
2	designation of an access organization or the requirements
3	therefor shall first be submitted for review to the cable
4	advisory committee as provided by rule established by the cable
5	advisory committee and its comments shall be incorporated into
6	the its final order.
7	(e) The designation of an access organization and the
8	determination of requirements for a designation shall be exempt
9	from chapter 103D."
10	SECTION 2. Section 440G-13, Hawaii Revised Statutes, is
11	amended to read as follows:

#### Report Title:

Cable Television Systems; Access Organizations; Cable Advisory Committee

#### Description:

Authorizes the director of commerce and consumer affairs to designate an access organization to oversee the development, operation, supervision, management, production, or broadcasting of programs for cable television channels; requires the director to also establish requirements for the designation of access organizations; and requires the cable advisory committee to advise access organizations on matters under chapter 440G, Hawaii Revised Statutes.
