## SENATE CONCURRENT RESOLUTION

REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO SURVEY WHETHER  
AND HOW WORKERS' COMPENSATION LAWS IN OTHER STATES ARE USED  
TO COVER EMPLOYEE DISABILITIES CAUSED BY MULTIPLE CHEMICAL  
SENSITIVITIES.

1 WHEREAS, although no consensus has been reached for a case  
2 definition of "multiple chemical sensitivities", according to  
3 the National Institutes of Health's National Institute of  
4 Environmental Health Sciences, the term, also known as "20th  
5 Century Syndrome", "environmental illness", "sick building  
6 syndrome", idiopathic environmental intolerance, and TILT  
7 (toxicant-induced loss of tolerance), can be defined as a  
8 chronic, recurring disease caused by a person's inability to  
9 tolerate an environmental chemical or class of foreign  
10 chemicals; and

11  
12 WHEREAS, multiple chemical sensitivities has been described  
13 as a group of sensitivities to extraordinarily low levels of  
14 environmental chemicals appearing to develop in some individuals  
15 without prior history following acute or chronic exposure to a  
16 wide variety of environmental agents including various  
17 pesticides, solvents, drugs, and air contaminants in so-called  
18 sick buildings; and

19  
20 WHEREAS, some researchers contend that the term multiple  
21 chemical sensitivities refer to complaints of patients who  
22 report recurrent nonspecific symptoms referable to multiple  
23 organ systems that the sufferers believe are provoked by  
24 exposure to low levels of chemical, biological, or physical  
25 agents, yet other researchers have found no consistent physical  
26 findings or laboratory abnormalities to differentiate multiple  
27 chemical sensitivities patients from the remainder of the  
28 population; and

29  
30 WHEREAS, while some researchers espouse various theories as  
31 to the causes of multiple chemical sensitivities, other



1 researchers either doubt the existence of the disease as there  
2 is little concrete evidence to support it, or suspect a  
3 psychosomatic cause; and  
4

5 WHEREAS, it is in the interest of the State of Hawaii to  
6 protect its workers who suffer from multiple chemical  
7 sensitivities; now, therefore,  
8

9 BE IT RESOLVED by the Senate of the Twenty-fourth  
10 Legislature of the State of Hawaii, Regular Session of 2007, the  
11 House of Representatives concurring, that the Legislative  
12 Reference Bureau is requested to survey whether and how workers'  
13 compensation laws in other states are used to cover employee  
14 disabilities caused by multiple chemical sensitivities; and  
15

16 BE IT FURTHER RESOLVED that the Legislative Reference  
17 Bureau is further requested to develop a workable model by which  
18 the State can cover disabilities caused by multiple chemical  
19 sensitivities through the State's workers' compensation law; and  
20

21 BE IT FURTHER RESOLVED that the Department of Labor and  
22 Industrial Relations is requested to provide assistance to the  
23 Legislative Reference Bureau, if requested; and  
24

25 BE IT FURTHER RESOLVED that the Legislative Reference  
26 Bureau is requested to submit its findings and recommendations,  
27 including any necessary proposed legislation, to the Legislature  
28 not later than twenty days prior to the convening of the Regular  
29 Session of 2008; and  
30

31 BE IT FURTHER RESOLVED that certified copies of this  
32 Concurrent Resolution be transmitted to the Director of the  
33 Legislative Reference Bureau and the Director of Labor and  
34 Industrial Relations.
