## SENATE CONCURRENT RESOLUTION

REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO STUDY CUSTODY EVALUATOR TRAINING MODELS APPLIED BY OTHER JURISDICTIONS.

WHEREAS, in the 2006 Regular Session, the Legislature 1 adopted Senate Concurrent Resolution No. 52 authorizing the 2 Committees on Human Services of the Senate and House of 3 Representatives to convene interim hearings on the Hawaii Family 4 Court; and 5 6 WHEREAS, the interim hearings were designed as a way to 7 make the Hawaii Family Court more accessible and family 8 friendly; and 9 10 WHEREAS, during the course of these interim hearings, a 11 task force was established along with working groups, that 12 submitted their findings and recommendations to the larger task 13 force; and 14 15 WHEREAS, while some of the working groups' recommendations 16 were adopted by the task force and have received legislative 17 attention, due to time constraints, there were other issues the 18 task force was unable to explore fully; and 19 20 WHEREAS, one area the task force was unable to fully 21 explore is the issue of training and oversight of custody 22 evaluators both in the Hawaii family courts and in other 23 jurisdictions; and 24 25 WHEREAS, being unable to fully explore and discuss custody 26 evaluator issues, the task force members are interested in 27 examining how other jurisdictions address training and oversight 28 of custody evaluators before determining a possible course of 29 action to take to improve custody evaluation in the Hawaii 30 family courts; now, therefore, 31 32
