## SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO STUDY THE AIR COOLING NEEDS OF EACH SCHOOL COMPLEX AND TO REVIEW THE FEASIBILITY OF USING ALTERNATIVE AIR COOLING METHODS SUCH AS FANS, HEAT REDUCTION, INSULATION, AND ENERGY EFFICIENT INDIVIDUAL AIR CONDITIONING WALL UNITS.

WHEREAS, students need to have the most conducive, 1 comfortable learning environment in order to achieve the 2 educational standards set for them; and 3 4 WHEREAS, the Legislature finds that a physical learning 5 environment that is free of unnecessary distractions from heat 6 or outside noise is crucial to student learning; and 7 8 WHEREAS, given Hawaii's tropical environment and heat, many 9 classrooms need to be equipped with air conditioning or 10 alternative air cooling methods; and 11 12 WHEREAS, despite a tremendous backlog of repair and 13 maintenance items and the need for new schools and facilities, 14 it is important to include air conditioning costs as part of a 15 comprehensive priority list of critical budget items for the 16 Department of Education (DOE); and 17 18 WHEREAS, DOE has projected that the provision of necessary 19 air conditioning to each school and school complex will cost 20 \$1,000,000,000 over the next five years; now, therefore, 21 22 BE IT RESOLVED by the Senate of the Twenty-fourth 23 Legislature of the State of Hawaii, Regular Session of 2007, the 24 House of Representatives concurring, that DOE is requested to 25 study the air cooling needs of each school complex and review 26 the feasibility of using alternative air cooling methods such as 27 fans, heat reduction, insulation, and energy efficient 28 individual air conditioning wall units; and 29

BE IT FURTHER RESOLVED that as part of the study, the Department is requested to include information on utility and maintenance costs for the proposed air cooling methods, information on any electrical upgrades that may be necessary for each school, a projected total cost, and a timetable for implementation; and

8 BE IT FURTHER RESOLVED that DOE is requested to submit a 9 report of its findings and recommendations to the Legislature no 10 later than 20 days prior to the convening of the Regular Session 11 of 2008; and

BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Superintendent of Education and the Chairperson of the Board of Education.
