## SENATE CONCURRENT RESOLUTION

## REQUESTING THE UNIVERSITY OF HAWAII TO DESIGN A LONG-TERM COMPREHENSIVE FINANCIAL PLAN.

WHEREAS, universities and colleges across the nation are 1 being required to more effectively align their state funds to 2 current and future needs and priorities of their states; and 3 4 5 WHEREAS, the funding available to universities and colleges are inadequate to meet the expectations of their states; and 6 7 WHEREAS, there are universities and colleges that have 8 9 developed long-term comprehensive financial plans either in 10 total or in part; and 11 WHEREAS, the University of Hawaii must have a realistically 12 13 attainable long-term balance among state general funds, tuition, and external funds that is adequate for the mandates for which 14 funding is provided; now, therefore, 15 16 BE IT RESOLVED by the Senate of the Twenty-fourth 17 Legislature of the State of Hawaii, Regular Session of 2007, the 18 House of Representatives concurring, that the University of 19 Hawaii is requested to develop a comprehensive long-term 20 financial plan that includes: 21 22 A survey of long-term comprehensive financial plans of 23 (1) other states' universities or systems to which the 24 University of Hawaii System can learn and emulate in 25 total or in part; 26 27 (2) An analysis of the adequacy of funding in relationship 28 to present and future university-designated and state-29 designated needs and priorities; 30 31 32 (3) A preferred balance among state general funds, tuition 33 income, and external funding to adequately fund the

1 mandates of the University of Hawaii and for those of 2 which the funding is adjoined; 3 (4) An alignment of the university's allocation of state 4 general funds to current and future needs and 5 priorities of the State; and 6 7 8 (5) A linking of resources to program objectives, e.g. increasing the number of college graduates, and 9 reducing shortage of teachers and nurses; and 10 11 BE IT FURTHER RESOLVED that the University of Hawaii 12 conduct a review of state and university system policies that 13 affect the ability of the system and its campuses to most 14 effectively utilize the resources made available; and 15 16 BE IT FURTHER RESOLVED that the University of Hawaii is 17 18 requested to submit its report and any findings and 19 recommendations to the Legislature not later than twenty days 20 prior to the convening of the Regular Session of 2008; and 21 22 BE IT FURTHER RESOLVED that certified copies of this 23 Concurrent Resolution be transmitted to the Chair of the Board 24 of Regents and the President of the University of Hawaii. 25 26 OFFERED BY: Norman Sakamon 27
