# SENATE CONCURRENT RESOLUTION

---

REQUESTING THE HAWAII PUBLIC HOUSING AUTHORITY TO REPORT ON  
PROJECT SPENDING.

1 WHEREAS, on July 1, 2006, the Housing and Community  
2 Development Corporation of Hawaii split into two separate  
3 agencies, the Hawaii Housing Finance and Development Corporation  
4 and the Hawaii Public Housing Authority pursuant to Act 196,  
5 Session Laws of Hawaii 2005, and Act 180, SLH 2006; and  
6

7 WHEREAS, the Hawaii Public Housing Authority is responsible  
8 for the management of federal and state funds for public housing  
9 programs and services; and  
10

11 WHEREAS, the Hawaii Public Housing Authority is also  
12 responsible for various functions related to public housing,  
13 including the development and operation of public housing  
14 projects and the administration of federal programs, the Public  
15 Housing Revolving Fund, homeless assistance, State Rent  
16 Supplement Program, and the Section 8 Housing Choice Voucher  
17 Program; and  
18

19 WHEREAS, the Legislature believes that all public agencies  
20 should be accountable for funds entrusted to them; and  
21

22 WHEREAS, because of the recent establishment of the Hawaii  
23 Public Housing Authority and the various sources of funds it is  
24 responsible for, the Legislature finds that it is appropriate to  
25 request that the Hawaii Public Housing Authority report on its  
26 project spending to ensure proper and effective use and  
27 management of funds; now, therefore,

29 BE IT RESOLVED by the Senate of the Twenty-fourth  
30 Legislature of the State of Hawaii, Regular Session of 2007, the  
31 House of Representatives concurring, that the Hawaii Public  
32 Housing Authority is requested to submit a report of its project



1 spending to the Legislature no later than twenty days prior to  
2 the convening of the Regular Session of 2008; and

4 BE IT FURTHER RESOLVED that the report should include:

6 (1) A list of all of the current projects for the  
7 development of public housing;  
8  
9 (2) A list of all of the projects for the development of  
10 public housing that were completed within the past two  
11 years;  
12  
13 (3) The amount and source or sources of funding for each  
14 of the projects;  
15  
16 (4) A list of all of the contracts for each project;  
17  
18 (5) A detailed description of how funding was expended or  
19 will be expended for each project; and  
20  
21 (6) A timeline for the completion of each project; and

23 BE IT FURTHER RESOLVED that the Hawaii Public Housing  
24 Authority is requested to submit a copy of the report of its  
25 project spending to the Auditor no later than twenty days prior  
26 to the convening of the Regular Session of 2008, as well; and

28 BE IT FURTHER RESOLVED that certified copies of this  
29 Concurrent Resolution be transmitted to the Interim Executive  
30 Director of the Hawaii Public Housing Authority and the Auditor.
