# SENATE CONCURRENT RESOLUTION

---

REQUESTING THE HAWAII PUBLIC HOUSING AUTHORITY TO REPORT ON  
PROJECT SPENDING.

1 WHEREAS, on July 1, 2006, the Housing and Community  
2 Development Corporation of Hawaii split into two separate  
3 agencies, the Hawaii Housing Finance and Development Corporation  
4 and the Hawaii Public Housing Authority pursuant to Act 196,  
5 Session Laws of Hawaii 2005, and Act 180, Session Laws of Hawaii  
6 2006; and

7  
8 WHEREAS, the Hawaii Public Housing Authority is responsible  
9 for the management of federal and state funds for public housing  
10 programs and services; and

11  
12 WHEREAS, the Hawaii Public Housing Authority is also  
13 responsible for various functions related to public housing,  
14 including the development and operation of public housing  
15 projects and the administration of federal programs, the Public  
16 Housing Revolving Fund, homeless assistance, State Rent  
17 Supplement Program, and the Section 8 Housing Choice Voucher  
18 Program; and

20 WHEREAS, the Legislature believes that all public agencies  
21 should be accountable for funds entrusted to them; and

22  
23 WHEREAS, because of the recent establishment of the Hawaii  
24 Public Housing Authority and the various sources of funds it is  
25 responsible for, the Legislature finds that it is appropriate to  
26 request that the Hawaii Public Housing Authority report on its  
27 project spending to ensure proper and effective use and  
28 management of funds; now, therefore,

30 BE IT RESOLVED by the Senate of the Twenty-fourth  
31 Legislature of the State of Hawaii, Regular Session of 2007, the  
32 House of Representatives concurring, that the Hawaii Public  
33 Housing Authority is requested to submit a report of its project



1 spending to the Legislature no later than twenty days prior to  
2 the convening of the Regular Session of 2008; and  
3

4 BE IT FURTHER RESOLVED that the report should include all  
5 project spending for all projects, including new, renovation, or  
6 modernization projects, as well as:  
7

8 (1) A list of all current projects for the development of  
9 public housing;  
10

11 (2) Information with respect to the forty-eight newly  
12 developed units at Lanakila Homes in Hilo;  
13

14 (3) The amount and source of funding for each project;  
15

16 (4) A list of all contracts executed for each project; and  
17

18 (5) A timeline for the completion of each project; and  
19

20 BE IT FURTHER RESOLVED that the Hawaii Public Housing  
21 Authority is requested to submit a copy of the report of its  
22 project spending to the Auditor no later than twenty days prior  
23 to the convening of the Regular Session of 2008, as well; and

25 BE IT FURTHER RESOLVED that certified copies of this  
26 Concurrent Resolution be transmitted to the Interim Executive  
27 Director of the Hawaii Public Housing Authority and the Auditor.
