## SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO DEVELOP COST ESTIMATES AND PLANS TO MAKE EXTENSIVE RENOVATIONS TO KAPAA, KAUAI, AND WAIMEA HIGH SCHOOL GYMNASIUMS.

WHEREAS, the gymnasiums of Kapaa, Kauai, and Waimea High 1 Schools were designed and built during the World War II Era 2 (1940s) and repaired once after Hurricane Iniki; and 3 4 WHEREAS, the structures are old and deteriorated and need 5 to be modernized; and 6 7 WHEREAS, the facilities are used for physical education 8 classes, intramural sports, high school athletics, cheerleading 9 practices, special events, school assemblies, and community 10 leagues; and 11 12 WHEREAS, it provides a source of school and community 13 pride; and 14 15 WHEREAS, physical activity remains an important part of a 16 growing child's psychological and physical development and 17 future well-being; and 18 19 WHEREAS, the facilities can serve as civil defense 20 shelters, of which there is a shortage statewide; now, 21 22 therefore, 23 24 BE IT RESOLVED by the Senate of the Twenty-fourth Legislature of the State of Hawaii, Regular Session of 2007, the 25 House of Representatives concurring, that the Department of 26 Education (Department) is requested to develop cost estimates 27 and design plans for new gymnasiums at Kapaa, Kauai, and Waimea 28 High Schools; and 29 30 BE IT FURTHER RESOLVED that the Department is requested to 31 work with the state Department of Defense and the County of 32

Kauai to determine whether the new gymnasiums should accommodate 1 civil defense needs, and, if so, the cost and source of funds to 2 make such accommodations; and 3 4 BE IT FURTHER RESOLVED that the Department is requested to 5 report its progress, findings, funding sources (e.g., the use of 6 state Civil Defense funds if the gymnasium is upgraded to a 7 shelter), and recommendations to the Legislature no later than 8 twenty days prior to the convening of the Regular Session 2008; 9 10 and 11 BE IT FURTHER RESOLVED that certified copies of this 12 Concurrent Resolution be transmitted to the Board of Education, 13 the Superintendent of Education, the state Department of 14 Defense, the principals of Kapaa, Kauai, and Waimea High 15 Schools, and the Mayor and County Council of the County of 16

17 Kauai.
