SENATE CONCURRENT RESOLUTION

CONDEMNING THE UNITED STATES CITIZENSHIP AND IMMIGRATION
SERVICES' FEE INCREASE.

1 WHEREAS, our Nation's and State's newcomers are making
2 valuable contributions to the social, cultural, and economic
3 life of the United States of America and the State of Hawaii;
4 and

5
6 WHEREAS, Hawaii is home to many hardworking, taxpaying,
7 legal permanent residents who are eager to become full Americans
8 by pursuing the dream of U.S. citizenship; and

9
10 WHEREAS, on January 31, 2007, the United States Citizenship
11 and Immigration Services (USCIS) announced a proposal that would
12 raise the fees for starting the naturalization process from \$400
13 to \$675, an increase of sixty-nine per cent; and

14
15 WHEREAS, the USCIS anticipates that the fee hike will go
16 into effect in June 2007; and

17
18 WHEREAS, naturalization fees have been soaring since 1991,
19 when legal permanent residents paid \$90 to apply for U.S.
20 citizenship; and

22 WHEREAS, naturalization fee increases result from our
23 Nation's fundamentally flawed system of financing immigration
24 services, which requires the USCIS to rely almost exclusively on
25 application fees to fund the delivery of services to immigrants;

28 WHEREAS, the USCIS believes that it needs this massive fee
29 hike to pay for major infrastructure investments and process
30 enhancements, such as improvements in the timeliness of
31 background checks, modernization of its outdated business
32 systems through technology upgrades, facilities improvements and



1 enhancements in its personnel training and recruitment programs;
2 and

4 WHEREAS, there are at least 100,000, legal permanent
5 residents in Hawaii who are eligible to apply for U.S.
6 citizenship; and

7
8 WHEREAS, according to data from the 2000 Census, 38.4 per
9 cent of Hawaii's non-citizen households have annual incomes that
10 are less than \$25,000; and

11
12 WHEREAS, the proposed fee increase would place a nearly
13 insurmountable barrier in the path of legal permanent residents
14 who seek to naturalize, many of whom have limited financial
15 resources; and

16
17 WHEREAS, this body believes that the system for funding
18 immigration services should be a partnership between newcomers
19 and the federal government where applicants pay a reasonable fee
20 for quality service; and

21
22 WHEREAS, the USCIS' proposed fee increase is contrary to
23 the spirit of our Nation's and State's tradition of welcoming
24 and integrating immigrants, and sends legal permanent residents
25 the wrong message at a time when they are seeking to embrace
26 U.S. citizenship; and

27
28 WHEREAS, naturalization benefits Hawaii by helping to
29 ensure that newcomers become full participants in our Nation's
30 civic life; and

31
32 WHEREAS, the full participation of newcomers enriches and
33 maintains the vitality of our democracy; now, therefore,

35 BE IT RESOLVED by the Senate of the Twenty-fourth
36 Legislature of the State of Hawaii, Regular Session of 2007, the
37 House of Representatives concurring, that the Legislature
38 condemns the proposed fee increase by USCIS and requests a halt
39 on the fee increase for all naturalization applications; and

41 BE IT FURTHER RESOLVED that the Legislature calls on the
42 Director of the USCIS to immediately provide President George W.
43 Bush and the U.S. Congress with accurate information to
44 ascertain the amount of federal appropriations that would be

1 needed to enable the USCIS to modernize its operations, and
2 enhance its naturalization services, without raising the
3 naturalization fee; and

5 BE IT FURTHER RESOLVED that the Legislature calls on
6 President George W. Bush and the United States Congress to
7 address the fundamental problems in our Nation's system for
8 financing immigration services by providing appropriations to
9 supplement fee revenue to cover costs of major USCIS expenses
10 such as infrastructure investments, process enhancements and
11 capital improvements; and

13 BE IT FURTHER RESOLVED that certified copies of this
14 Concurrent Resolution be transmitted to the Director of the
15 USCIS, the President of the United States, the Speaker of the
16 United States House of Representatives, the President Pro
17 Tempore of the United States Senate for inclusion in the
18 Congressional Record, and each member of Hawaii's Congressional
19 delegation.
